Presentation by Jeffery R Young, managing director of JR Conveyors and JR Engineering in Support of Springvale Mine Extension MOD 1-D459/17.

I would like to thank the commissioners for the opportunity to speak today. My name is Jeff Young, born and bred in Lithgow. I am the owner of JR Engineering and JR Conveyors, contracting companies which have been operating in Lithgow for the past 12 years. I am a 4th generation miner and my children, nephews and nieces are 5th generation workers in this town.

The Lithgow district is familiar to industry and is very reliant on it. We have a good history of coal mining which, although the number of mines has decreased, the importance of coal production remains the same. The coal industry creates work opportunities not only at the mine site but also in related service industries. Mt Piper Power Station is dependent on coal to produce electricity.

The increase in employment at Springvale will give more people opportunities in securing themselves a brighter future and lifestyle. Extra coal ensures ability of max power output at Mt Piper power station which once again secures peoples employment.

For every coal miner employed there is approximately five outside services persons employed. This effect rolls out through the community with more employment and the community being settled and assured of their future.

Sport is one main factor of well-being and healthiness within the community. Families with uncertainty of employment will defer from taking their children to sporting competitions which then will add to obesity and illness in our community. We need to support this application by Springvale Colliery as an important contributor to "keeping the dream alive".



Lithgow has and can provide us with a good and safe district to live and raise our children. We need to keep our employment here and promote industry.
