- This will arrow calculation of the maximum, minimum, and average energy, means the same per many the same estimation of the average output energy from the turbine system has to be made. This will inevitably be incorrect as no one can accurately estimate the variability of wind velocity Measurements taken over a long period, say 3 years, might provide some average data

If the above figures are developed a calculation of the number of homes that could be powered is possible resulting in a minimum, maximum and average numbers, BUT the results would still be highly inaccurate due to ill-defined actual wind velocity variation
