



## NOTICE OF PUBLIC HEARINGS

### Port Waratah Coal Services, Terminal Number 4 (T4) Newcastle Local Government Area

The former Minister for Planning, pursuant to Section 23D of the NSW *Environmental Planning and Assessment Act 1979*, has directed the Planning Assessment Commission to review the proposed Port Waratah Coal Services Terminal Number 4, and hold a public hearing during the review.

The Commission comprises:

- Mr Paul Forward (chair);
- Mr Brian Gilligan; and
- Mr Joe Woodward PSM.

The terms of reference for the Commission are:

1. Carry out a review of the Port Waratah Coal Services Terminal 4 Project (MP10\_0125), and;
  - a. consider the Environmental Assessment of the project, issues raised in public and agency submissions of the project, and any other information provided during the course of the review;
  - b. assess the merits of the project as a whole, paying particular attention to the potential:
    - noise and air quality impacts of the project;
    - traffic impacts of the project;
    - biodiversity and contamination impacts of the project;
    - any other potentially significant impacts of the project; and
  - c. recommend appropriate measures to avoid, minimise and/or offset these impacts.
2. Conduct public hearings during the carrying out of the review.
