I come from coal mining families. My mother's brothers all worked in Witton mines. One tragically died there in a mining accident. All suffered respiratory conditions no doubt due to working underground.

On my father's side, as a child he experienced the Stanley Mine Disaster in Durham (UK <sup>the village where he lived</sup>) which resulted in the death of 163 miners, devastating this community for generations.

Also my father worked underground in Durham & The Hunter in NSW.

I wish to establish that I am not unaware of the Witton community or the coal mining community.

Today's conditions for workers are excellent but coal mining continues to have a severe negative impact on the environment.

I have seen first hand the:

- a) Cracking of the surface of the Newnes Plateau (cracks that my whole body could fit into).
- b) Collapses of the cliff walls in the valleys of the Garden of Stones and,
- c) Draining of the unique high plateau swamps of the Newnes Plateau.

#### In a NUTSHELL

[REDACTED] submission directly addresses the environmental impact of the Spring Vale mine extension.

Therefore if mining is to proceed there must be:

No ground cracking,

No collapses of cliffs into the Garden of Stones;

No drainage of surface water from swamps

& No pollution of streams & waterways.

(Personally, I cannot see how mining this area would not cause the above from happening).

### Economy.

Under the current world wide policies on CO<sub>2</sub> reduction and the success of low emission and renewable energy technologies, dependence on coal as an energy source is declining rapidly.
