PART A ADMINISTRATIVE CONDITIONS

OBLIGATION TO MINIMISE HARM TO THE ENVIRONMENT

A1. In meeting the specific performance measures and criteria in this consent, all reasonable and feasible measures must be implemented to prevent, and if prevention is not reasonable and feasible, minimise, any material harm to the environment that may result from the construction, commissioning, operation, upgrading, decommissioning or rehabilitation of the development.

TERMS OF CONSENT

- A2. The development may only be carried out:
 - (b) in compliance with the conditions of this consent;
 - (c) in accordance with all written directions of the Planning Secretary;
 - (d) generally in accordance with the EIS; and
 - (e) generally in accordance with the Development Layout in Appendix 1.
- A3. The Applicant must comply with any requirement/s of the Planning Secretary arising from the Department's assessment of:
 - (a) any strategies, plans or correspondence that are submitted in accordance with this consent;
 - (b) any reports, reviews or audits commissioned by the Department regarding compliance with this consent; and
 - (c) the implementation of any actions or measures contained in these documents.
- A4. The conditions of this consent and directions of the Planning Secretary prevail to the extent of any inconsistency, ambiguity or conflict between them and a document listed in condition A2(d) or A2(e). In the event of an inconsistency, ambiguity or conflict between any of the documents listed in condition A2(d) or A2(d), the most recent document prevails to the extent of the inconsistency, ambiguity or conflict.

BATTERY STORAGE RESTRICTION

- A5. Unless the Planning Secretary agrees otherwise, the battery storage associated with the development must not exceed a total delivery capacity of 600 MW.
 - Note: This condition does not prevent the Applicant from seeking to lodge a separate development application or modify this consent to increase the capacity of the battery storage in the future.
- A6. Any building or fire rated compartment containing lithium-ion batteries shall be less than or equal to an energy storage capacity of 25 MWh.

UPGRADING OF SOLAR PANELS AND ANCILLARY INFRASTRUCTURE

A7. The Applicant may upgrade the solar panels and ancillary infrastructure on site provided these upgrades remain within the approved development footprint of the site. Prior to carrying out any such upgrades, the Applicant must provide revised layout plans and project details of the development to the Planning Secretary incorporating the proposed upgrades.

STRUCTURAL ADEQUACY

A8. The Applicant must ensure that all new buildings and structures, and any alterations or additions to existing buildings and structures, are constructed in accordance with the relevant requirements of the *National Construction Code*.

Notes:

- Under Part 6 of the EP&A Act, the Applicant is required to obtain construction and occupation certificates for the development.
- EP&A (Development Certification and Fire Safety) Regulation 2021 sets out the requirements for the certification of the development.

DEMOLITION

A9. The Applicant must ensure that all demolition work on site is carried out in accordance with *Australian Standard AS 2601-2001: The Demolition of Structures*, or its latest version.

PROTECTION OF PUBLIC INFRASTRUCTURE

- A10. Unless the Applicant and the applicable authority agree otherwise, the Applicant must:
 - (a) repair, or pay the full costs associated with repairing, any public infrastructure that is damaged by the development; and
 - (b) relocate, or pay the full costs associated with relocating, any public infrastructure that needs to be relocated as a result of the development.

Note: This condition does not apply to the upgrade and maintenance of the road network, which is expressly provided for in the conditions of this consent.

OPERATION OF PLANT AND EQUIPMENT

- A11. The Applicant must ensure that all plant and equipment used on site, or in connection with the development, is:
 - (a) maintained in a proper and efficient condition; and
 - (b) operated in a proper and efficient manner.

SUBDIVISION

A12. The Applicant may subdivide land comprising the site for the purposes of carrying out the development as generally identified in Appendix 3 and in accordance with the requirements of the EP&A Act, EP&A Regulation and the *Conveyancing Act 1919* (NSW).

Notes.

- Under Part 6 of the EP&A Act, the Applicant is required to obtain a subdivision certificate for a plan of subdivision.
- Division 6.4 of Part 6 of the EP&A Act sets out the application requirements for subdivision certificates.

APPLICABILITY OF GUIDELINES

A13. References in the conditions of this consent to any guideline, protocol, Australian Standard or policy are to such guidelines, protocols, Standards or policies in the form they are in as at the date of this consent.

However, consistent with the conditions of this consent and without altering any limits or criteria in this consent, the Planning Secretary may, when issuing directions under this consent in respect of ongoing monitoring and management obligations, require compliance with an updated or revised version of such a quideline, protocol, Standard or policy, or a replacement of them.

COMPLIANCE

A14. The Applicant must ensure that all of its employees, contractors (and their sub-contractors) are made aware of, and are instructed to comply with, the conditions of this consent relevant to activities they carry out in respect of the development.

EVIDENCE OF CONSULTATION

- A15. Where conditions of this consent require consultation with an identified party, the Applicant must:
 - (a) consult with the relevant party prior to submitting the subject document to the Planning Secretary for approval; and
 - (b) provide details of the consultation undertaken including:
 - (i) the outcome of that consultation, matters resolved and unresolved; and
 - (ii) details of any disagreement remaining between the party consulted and the Applicant and how the Applicant has addressed the matters not resolved.

COMMUNITY ENHANCEMENT

- A16. Prior to commencing construction, unless the Planning Secretary agrees otherwise, the Applicant must enter into a VPA with Mid-Western Regional Council in accordance with:
 - (a) Division 7.1 of Part 7 of the EP&A Act; and
 - (b) the terms of the agreement between the Applicant and Mid-Western Regional Council dated 12 July 2023, which are summarised in Appendix 4.

PART B ENVIRONMENTAL CONDITIONS

TRANSPORT

Heavy Vehicles Requiring Escort and Heavy Vehicle Restrictions

- B1. The Applicant must ensure that the:
 - (a) development does not generate more than:
 - (i) 120 heavy vehicle movements a day (a maximum of 27 heavy vehicle movements per hour) during construction, upgrading, or decommissioning;
 - (ii) a total of 6 movements of heavy vehicles requiring escort during construction, upgrading, and decommissioning:
 - (b) length of any vehicles (excluding heavy vehicles requiring escort) used for the development does not exceed 26 metres,

unless the Planning Secretary agrees otherwise.

B2. The Applicant must keep accurate records of the number of heavy vehicles requiring escort and heavy vehicles entering or leaving the site each day for the duration of the project.

Access Route

- B3. Unless the Planning Secretary agrees otherwise, all heavy vehicles and heavy vehicles requiring escort associated with the development must travel to and from the site via Castlereagh Highway, Barneys Reef Road and Birriwa Bus Route South, as shown in Figure 1 of Appendix 5.
- B4. All vehicles including private vehicles of employees, contractors and sub-contractors associated with the construction, operation, upgrading and decommissioning of the development must not use Merotherie Road, Birriwa Bus Route North or any parts of Birriwa Bus Route South not part of the proposed public road crossings, or shown as part of the access route in Figure 1 of Appendix 5 at any time except for emergency purposes, unless the Planning Secretary agrees otherwise.

Site Access

B5. All vehicles including private vehicles of employees, contractors and sub-contractors associated with the construction, operation and decommissioning of the development must enter and exit the site via the site access point off Birriwa Bus Route South, as identified in Appendix 1.

Access between portions of the site via the public road network must only be undertaken at the three crossing points on Birriwa Bus Route South identified in the figure in Appendix 1.

Note: Other site access points identified in the figure in Appendix 1 of this consent may be used for emergency purposes.

Road Upgrades

B6. Unless the Planning Secretary agrees otherwise, prior to commencing construction, the Applicant must complete the road upgrades as detailed in Appendix 5.

Unless the relevant roads authority (and TfNSW for upgrades to the State Road network) agrees otherwise, these upgrades must comply with the *Austroads Guide to Road Design* (as amended by TfNSW supplements) and be carried out to the satisfaction of the relevant roads authority (and TfNSW for upgrades to the State Road network).

B7. Unless the Planning Secretary agrees otherwise, prior to commencing construction, the Applicant must provide a revised Strategic Concept Design (that meet the requirements set out in Appendix 7) for the Castlereagh Highway / Barneys Reef Road intersection design (as identified in Appendix 5), to the satisfaction of TfNSW.

Road Upgrades: Heavy Vehicles Requiring Escort

B8. Prior to the use of heavy vehicles requiring escort on the public road network, all relevant approvals must be obtained and implemented (including for any road upgrades that may be required from point of origin to the Castlereagh Highway/Barneys Reef Road intersection).

Road Maintenance

- B9. The Applicant must:
 - (a) undertake independent dilapidation surveys to assess the:
 - (i) existing condition of Barneys Reef Road and Birriwa Bus Route South between the

- intersection with Castlereagh Highway and the Site Access point, and also the parts of Birriwa Bus Route South identified as public road crossing locations in Appendix 1, following upgrade in accordance with condition B5 and prior to construction, upgrading and decommissioning activities; and
- (ii) condition of Barney's Reef Road and Birriwa Bus Route South between the intersections with Castlereagh Highway and the Site Access Point, and also the parts of Birriwa Bus Route South identified as public road crossing locations in Appendix 1, following completion of construction, upgrading and decommissioning activities;
- (b) on completion of the dilapidation reports undertaken in B9(a)(i) and (ii) provide a copy to the relevant roads' authorities; and
- (c) repair and/or make good any development-related damage to Barneys Reef Road and Birriwa Bus Route South (including the public road crossing points), identified in dilapidation surveys during construction, upgrading or decommissioning works in consultation with the relevant road authority. Repair and/or make good works must be completed within 2 months of completion of the dilapidation surveys.

If there is a dispute between the Applicant and the relevant roads authority about repairs required under this condition then either party may refer the matter to the Planning Secretary for resolution.

Operating Conditions

- B10. The Applicant must ensure:
 - (a) the internal roads are constructed as all-weather roads:
 - (b) there is sufficient parking on site for all vehicles, and no parking occurs on the public road network in the vicinity of the site;
 - (c) the capacity of the existing roadside drainage network is not reduced;
 - (d) all vehicles are loaded and unloaded on site, and enter and leave the site in a forward direction;and
 - (e) development related vehicles (including private vehicles of employees, contractors and subcontractors associated with the construction, operation, upgrading and decommissioning of the development), leaving the site are in a clean condition to minimise dirt being tracked onto the public road network.

Traffic Management Plan

- B11. Prior to commencing the road upgrades identified in condition B6 of this consent, the Applicant must prepare a Traffic Management Plan for the development in consultation with TfNSW, Mid-Western Regional Council and Warrumbungle Shire Council and to the satisfaction of the Planning Secretary. This plan must include:
 - (a) details of the transport route to be used for development-related traffic;
 - (b) details of the road upgrade works required by condition B6 of this consent;
 - (c) a reconciliation table to demonstrate all traffic-related management measures and recommendations identified in the EIS have been included in the plan;
 - (d) details of the measures that would be implemented to minimise traffic impacts during construction, upgrading or decommissioning works, including:
 - (i) details of the dilapidation surveys required by condition B9 of this consent;
 - (ii) temporary traffic controls, including detours and signage;
 - (iii) notifying the local community about project-related traffic impacts;
 - (iv) procedures for receiving, addressing, and responding in a timely manner to complaints from the community about development related traffic;
 - minimising potential for conflict with school buses and other road users (including cyclists utilising the Central West Cycle Trail and stock permit holders moving stock) as far as practicable, including preventing queuing on the public road network;
 - (vi) minimising potential cumulative traffic impacts with other projects in the area during construction, upgrading or decommissioning works;
 - (vii) minimising dirt tracked onto the public road network from development-related traffic (including private vehicles of employees, contractors and sub-contractors associated with the construction, operations, upgrading and decommissioning of the development);
 - (viii) measures for managing light vehicle peak numbers, including carpooling or ride sharing by employees;
 - (ix) scheduling of heavy vehicle movements to minimise convoy length or platoons, and to minimise conflict with light vehicles;
 - (x) responding to local climate conditions that may affect road safety such as fog, dust, wet weather:

- responding to any emergency repair or maintenance requirements and the timing for such a response;
- (xii) a traffic management system for managing heavy vehicles requiring escort;
- (xiii) procedures on how stock permit holders (as outlined under the Local Land Services Act 2013), will maintain their access to the local road network; and
- (xiv) identification of proposed access routes from point of collection to point of disposal for waste vehicles servicing the development;
- (e) a driver's code of conduct that addresses:
 - (i) driver fatigue;
 - (ii) procedures to ensure that drivers, including employees, contractors and sub-contractors using private vehicles adhere to the designated transport routes and speed limits; and
 - (iii) procedures to ensure that drivers implement safe driving practices;
- (f) a program to ensure drivers working on the development receive suitable training on the code of conduct and any other relevant obligations under the Traffic Management Plan; and
- a flood response plan detailing procedures and options for safe access to and from site in the event of flooding; and
- (h) include details of who would be responsible for monitoring, reviewing, reporting and implementing the Traffic Management Plan.

Following the Planning Secretary's approval, the Applicant must implement the Traffic Management Plan.

LANDSCAPING

Vegetation Buffer

- B12. The Applicant must establish and maintain a vegetation buffer (landscape screening) as described in the EIS and shown in Appendix 1. The landscape screening must:
 - (a) commence being planted within 9 months of the commencement of construction of the solar arrays, with all landscape screening fully planted prior to commencement of operation of the development;
 - (b) be comprised of species that are endemic to the area comprising of a mix of tube stock and 15L 40L pot size;
 - be designed and maintained in accordance with RFS's Planning for Bushfire Protection 2019 (or equivalent); and
 - (d) be properly maintained for the life of the development, including appropriate weed management and replacement of mortalities upon identification,

unless the Planning Secretary agrees otherwise.

Land Management

- B13. The Applicant must maintain the agricultural land capability of the site, including:
 - (a) establishing the ground cover of the site within 3 months following the completion of any construction or upgrading;
 - (b) properly maintaining the ground cover with appropriate perennial species and weed management;
 - (c) maintaining grazing within the development footprint, where practicable, with related livestock infrastructure provided.

unless the Planning Secretary agrees otherwise.

Visual

- B14. The Applicant must:
 - (a) minimise the off-site visual impacts of the development, including the potential for any glare or reflection;
 - (b) ensure the visual appearance of all ancillary infrastructure (including paint colours) blends in as far as possible with the surrounding landscape; and
 - (c) not mount any advertising signs or logos on site, except where this is required for identification or safety purposes.

Lighting

- B15. The Applicant must:
 - (a) minimise the off-site lighting impacts of the development; and
 - (b) ensure that any external lighting associated with the development:
 - is installed as low intensity lighting (except where required for safety or emergency purposes);
 - (ii) does not shine above the horizontal plane and does not shire directly outside the site; and
 - (iii) complies with Australian Standard/New Zealand Standard AS/NZS 4282:2019 Control of Obtrusive Effects of Outdoor Lighting, or the latest version.

Rural Landscape Character

- B16. Prior to the commencement of works, the Applicant must
 - (a) discuss with Mid-Western Regional Council opportunities to develop and implement a program of road reserve vegetation planting along:
 - (i) Birriwa Bus Route North between receivers R1 and R30; and
 - (ii) Birriwa Bus Route South, between receiver R5 and associated dwelling A4.
 - (b) The program must describe:
 - (i) type, width and density of plantings;
 - (ii) timing of planting;
 - (iii) that the vegetation is designed and will be maintained in accordance with RFS's Planning for Bushfire Protection 2019 (or equivalent); and
 - (iv) planting locations to ensure road safety and no conflict with road users.

If a program is agreed to by Mid-Western Regional Council, a copy is to be published on the Applicant's website and the program implemented prior to commencement of operations. If an agreement cannot be reached with Mid-Western Regional Council, this does not preclude the commencement of the development.

B17. Where practicable and possible, the design of the final solar array layout is to avoid the removal of existing isolated mature trees on the site.

BIODIVERSITY

Vegetation Clearance

B18. The Applicant must not clear any native vegetation or fauna habitat located outside the approved disturbance areas described in the EIS.

Biodiversity Offsets

- B19. Prior to carrying out any development that could directly or indirectly impact the biodiversity values requiring offset, in accordance with the timing in Table 1 below, the Applicant must retire biodiversity credits of a number and class specified in Table 2 and Table 3 below. The retirement of these credits must be carried out in accordance with the NSW *Biodiversity Offsets Scheme* and can be achieved by:
 - (a) acquiring or retiring 'biodiversity credits' within the meaning of *the Biodiversity Conservation Act* 2016:
 - (b) making payments into an offset fund that has been developed by the NSW Government; and/or
 - (c) funding a biodiversity conservation action that benefits the entity impacted and is listed in the ancillary rules of the biodiversity offset scheme.

Table 1. Timing for retirement of biodiversity credits

B20. Prior to carrying out any development that could directly or indirectly impact the biodiversity values requiring offset, the Applicant must provide evidence to the Planning Secretary that biodiversity credits have been retired.

Biodiversity Management Plan

- B21. Prior to carrying out any development that could directly or indirectly impact biodiversity values, the Applicant must prepare a Biodiversity Management Plan for the development in consultation with BCS, and to the satisfaction of the Planning Secretary. This plan must:
 - (a) be prepared in accordance with the *Biodiversity Development Assessment Report* (dated 27 September 2023);
 - (b) include a description of the measures that would be implemented for:
 - (i) protecting vegetation and fauna habitat outside the approved disturbance areas, including how the accommodation camp and its occupants will implement those measures;
 - (ii) managing and enhancing the remnant vegetation and fauna habitat on site;
 - (iii) minimising clearing and avoiding unnecessary disturbance of vegetation that is associated with the construction and operation of the development;
 - (iv) minimising the impacts to fauna on site and implementing fauna management protocols;
 - (v) avoiding the removal of hollow-bearing trees during spring to avoid the main breeding period for hollow-dependent fauna;
 - rehabilitating and revegetating temporary disturbance areas with native species that are appropriate to the site's ecology and conditions;
 - (vii) maximising the salvage of vegetative and soil resources within the approved disturbance area for beneficial reuse in the enhancement or the rehabilitation of the site; and
 - (viii) controlling weeds, feral pests and pathogens;
 - (c) include a program to monitor and report on the effectiveness of mitigation measures and report to BCS following each annual reporting window;
 - (d) include an incidental threatened species finds protocol to identify, avoid and/or minimise and/or offset options to be implemented if additional threatened species are discovered on site; and
 - (e) include details of who would be responsible for monitoring, reviewing, reporting on and implementing the plan.

Following the Planning Secretary's approval, the Applicant must implement the Biodiversity Management

Plan prior to carrying out any development that could directly or indirectly impact biodiversity values.

AMENITY

Construction, Upgrading and Decommissioning Hours

- B22. Unless the Planning Secretary agrees otherwise, the Applicant may only undertake road upgrades, transportation of materials to and from site, construction, upgrading, commissioning or decommissioning activities on site between:
 - (a) 7 am to 6 pm Monday to Friday;
 - (b) 8 am to 1 pm Saturdays; and
 - (c) at no time on Sundays and NSW public holidays.

Exceptions to Construction Hours

- B23. The following activities may be carried out outside the hours specified in condition B22 above:
 - (a) commissioning activities that are inaudible at non-associated residences;
 - (b) the delivery or dispatch of materials as requested by the NSW Police Force or other public authorities for safety reasons; or
 - (c) emergency work to avoid the loss of life, property or prevent material harm to the environment.

Variation of Construction Hours

- B24. The hours of construction activities specified in condition B22 of this approval may be varied with the prior written approval of the Planning Secretary. Any request to alter the hours of construction must be:
 - (a) considered on a case-by-case or activity-specific basis;
 - (b) accompanied by details of the nature and justification for activities to be conducted during the varied construction hours;
 - (c) accompanied by written evidence that appropriate consultation with potentially affected sensitive receivers and notification of relevant Councils (and other relevant agencies) has been undertaken;
 - (d) accompanied by evidence that all feasible and reasonable noise mitigation and traffic management measures have been put in place; and
 - (e) accompanied by a noise impact assessment consistent with the requirements of the *Interim Construction Noise Guideline* (DECC, 2009), or latest version.

Noise

- B25. The Applicant must:
 - (a) minimise the noise generated by any construction, upgrading or decommissioning activities on site in accordance with best practice requirements outlined in the *Interim Construction Noise Guideline* (DECC, 2009) or its latest version; and
 - (b) take all reasonable and feasible steps to minimise operational noise and ensure that the noise generated by the operation of the development does not exceed the noise limits in Table 4 below to be determined in accordance with the procedures in the NSW Noise Policy for Industry (EPA, 2017) at any non-associated residences unless the Planning Secretary agrees otherwise.

- B26. Unless the Planning Secretary agrees otherwise, within 3 months of the commencement of operation, the Applicant must prepare and submit a Noise Monitoring Report for the development to the satisfaction of the Planning Secretary. The Noise Monitoring Report must:
 - (a) be prepared by a suitably qualified, experienced and independent acoustic consultant;
 - (b) demonstrate that noise monitoring:
 - (i) has been carried out in accordance with the procedures in the Noise Policy for Industry (EPA, 2017); and
 - includes monitoring during the day, evening and night periods during operational, temperature and meteorological conditions that would represent typical worst-case

scenarios where reasonable and feasible;

(c) include:

- 1/3 octave data and calculated sound power levels along with a discussion of any excessive annoying characteristics and directionality;
- (ii) an analysis of compliance with the noise limits specified in condition B25 at R5 at R12 and R13;
- (iii) an outline of implemented at-source and transmission pathway mitigation measures and their effectiveness at reducing operational noise; and
- (iv) a description of contingency measures in the event implemented mitigation measures are not effective at reducing noise levels to comply with limits specified in condition B25 at R5, R12 and R13 at all times.

The Applicant must publish all Noise Monitoring Reports on its website and undertake further noise monitoring of the development if required by the Planning Secretary.

Dust

B27. The Applicant must minimise the dust generated by the development.

Location of Solar Panels

B28. No solar panel is to be located closer than 30 metres to the Site boundary, however other ancillary works such and fencing and landscaping are permitted within 30 metres of the site boundary.

HERITAGE

Protection of Heritage Items

B29. The Applicant must ensure the development does not cause any direct or indirect impacts to the Aboriginal heritage items identified in Table 1 in Appendix 6 or any heritage items outside the approved development footprint.

Heritage Management Plan

- B30. Prior to commencing construction, the Applicant must prepare a Heritage Management Plan for the development to the satisfaction of the Planning Secretary. This plan must:
 - (a) be prepared by suitably qualified and experienced persons whose appointment has been endorsed by the Planning Secretary in writing;
 - (b) be prepared in consultation with Local Aboriginal Stakeholders, and reviewed by Heritage NSW;
 - (c) include a description of the measures that would be implemented for:
 - (i) protecting the Aboriginal heritage items identified in Table 1 of Appendix 6, or items located outside of the approved development footprint;
 - fencing / demarcation (as appropriate) of the identified heritage items prior to carrying out any development that could directly or indirectly impact the identified heritage items;
 - (iii) salvaging and relocating the heritage items located within the approved development footprint, as identified in Table 2 of Appendix 6;
 - (iv) a contingency plan and reporting procedure if:
 - · heritage items outside the approved development footprint are damaged;
 - · previously unidentified heritage items are found; or
 - · skeletal material is discovered;
 - ensuring workers on site receive suitable heritage inductions prior to carrying out any development on site, and that records are kept of these inductions; and
 - (vi) ongoing consultation with Aboriginal stakeholders during the implementation of the plan;
 - (d) include a program to monitor and report on the effectiveness of these measures and any heritage impacts of the project, including details on how, when and to whom monitoring reports will be made available.

Following the Planning Secretary's approval, the Applicant must implement the Heritage Management Plan.

SOIL AND WATER

Water Supply

B31. The Applicant must ensure that it has sufficient water for all stages of the development, and if necessary,

adjust the scale of the development to match its available water supply.

Note: Under the Water Act 1912 and/or the Water Management Act 2000, the Applicant is required to obtain the necessary water licences for the development.

Water Pollution

B32. The Applicant must ensure that the development does not cause any water pollution, as defined under Section 120 of the *Protection of the Environment Operations Act 1997*.

Operating Conditions

- B33. The Applicant must:
 - (a) minimise erosion and control sediment generation;
 - (b) ensure any solar panels, the battery storage system, accommodation camp, ancillary infrastructure and any other land disturbance associated with the construction, upgrading or decommissioning of the development have appropriate drainage and erosion and sediment controls designed, installed and maintained in accordance with *Managing Urban Stormwater: Soils and Construction* (Landcom, 2004) and the *Managing Urban Stormwater: Soils and construction Volume 2A* manual (Landcom, 2008), or their latest versions:
 - (c) ensure the solar panels, the battery storage system, accommodation camp and ancillary infrastructure (including security fencing) are designed, constructed and maintained to reduce impacts on surface water, localised flooding and groundwater at the site;
 - (d) ensure the solar panels, the battery storage system, accommodation camp and ancillary infrastructure do not cause any increased water being diverted off the site or alter hydrology off site:
 - (e) ensure the solar panels, the battery storage system, accommodation camp and ancillary infrastructure are designed, constructed and maintained to retain groundcover and avoid causing any erosion on site;
 - (f) ensure all works within waterfront land is undertaken in accordance with *Guidelines for Controlled Activities on Waterfront Land* (DPE, 2022) and that any stream or creek line rehabilitation is undertaken in consultation with the DCCEEW Water Group; and
 - (g) ensure the design of the all creek crossings (including internal tracks and MV cables) is in accordance with the document *Why do Fish Need to Cross the Road? Fish Passage Requirements for Waterway Crossings (NSW Fisheries 2003)* and the *Policy and Guidelines for Fish Habitat Conservation and Management (Update 2013)*.

Soil and Water Management Plan

- B34. Prior to commencing construction, the Applicant must prepare a Soil and Water Management Plan for the development in consultation with NSW DCCEEW Water Group. This plan must:
 - (a) be prepared by suitably qualified, experienced and practicing professionals;
 - (b) include a description of the measures that would be implemented to ensure that the objectives of condition B33 (a) (g) above are achieved;
 - (c) include a program to monitor and report on the effectiveness of these measures, including potential impacts to waterways within the site, and details on how and when monitoring reports will be made publicly available; and
 - (d) include details of who would be responsible for monitoring, reviewing, reporting and implementing the plan, and timeframes for completion of actions.

The Applicant must implement the Soil and Water Management Plan.

HAZARDS

Fire Safety Study

- B35. Prior to commencing construction of the battery storage facility (except for construction of those preliminary works that are outside the scope of the hazard studies), the Applicant must prepare and submit a Fire Safety Study for the battery storage, to the satisfaction of the Planning Secretary and that meets the requirements of FRNSW. The study must:
 - (a) be consistent with the Department's *Hazardous Industry Planning Advisory Paper No. 2 'Fire Safety Study' guideline*;
 - (b) be prepared in accordance with the FRNSW Fire Safety Guideline Technical Information Large scale external lithium-ion battery energy storage systems Fire safety study considerations.

- (c) describe the final design of the battery storage;
- (d) for the option of purpose-built battery storage building, report the controls adopted and demonstrate consistency with the hazard controls described in the Preliminary Hazard Analysis (Sherpa, 20 July 2022) and Submissions Report (EMM, Final, 12 September 2023);
- (e) include reasonable worst-case fire scenario to and from the battery storage and the associated fire management; and
- (f) identify measures to eliminate the expansion of any fire incident including:
 - (i) adequate fire safety systems and appropriate water supply;
 - (ii) separation and / or compartmentalisation of battery units; and
 - (iii) strategies and incident control measures specific to the battery storage design.

Following approval by the Planning Secretary, the Applicant must implement the measures described in the Fire Safety Study.

Note: 'meets the requirements of FRNSW' above means confirmation in writing from FRNSW that the Study meets the requirements of FRNSW as required by the Department's Hazardous Industry Planning Advisory Paper No. 2 'Fire Safety Study' guideline.

Storage and Handling of Dangerous Materials

- B36. The quantities of dangerous goods stored and handled at the site must be below the threshold quantities listed in the Department's Hazardous and Offensive Development Application Guidelines Applying SEPP 33 at all times.
- B37. The Applicant must store and handle all chemicals, fuels and oils used on-site in accordance with:
 - (a) the requirements of all relevant Australian Standards; and
 - (b) the NSW EPA's *Storing and Handling of Liquids: Environmental Protection Participants Handbook* if the chemicals are liquids.

In the event of an inconsistency between the requirements listed from (a) and (b) above, the most stringent requirement must prevail to the extent of the inconsistency.

Operating Conditions - Solar and Battery Storage

- B38. For the solar and battery storage components of the development, the Applicant must:
 - (a) minimise the fire risks of the development, including managing vegetation fuel loads on-site;
 - (b) ensure that the development:
 - (i) complies with the relevant asset protection requirements in the RFS's *Planning for Bushfire Protection 2019* (or equivalent) and *Standards for Asset Protection Zones*;
 - (ii) is suitably equipped to respond to any fires on site, including provision of a 50,000 litre water supply tank fitted with a 65 mm Storz fitting and a FRNSW compatible suction connection:
 - (iii) includes a minimum 10 metre defendable space around the perimeter that permits unobstructed vehicle access, and assists the RFS and emergency services as much as practicable if there is a fire in the vicinity of the site; and
 - (iv) is managed as an asset protection zone (including the defendable space);
 - (c) assist the RFS, FRNSW and emergency services as much as practicable if there is a fire in the vicinity of the site; and
 - (d) notify the relevant local emergency management committee following completion of construction of the development, and prior to commencing operations.

Operating Conditions - Accommodation Camp

- B39. For the accommodation camp, the Applicant must:
 - (a) minimise the fire risks of the development, including managing vegetation fuel loads on-site;
 - (b) ensure that the development:
 - (i) complies with the relevant asset protection requirements in the RFS's *Planning for Bushfire Protection 2019* (or equivalent) and *Standards for Asset Protection Zones*;
 - (ii) internal roads and utilities are provided in accordance with the requirements of the bushfire assessment report produced by Cool Burn Fire + Ecology (dated 29 August 2023);
 - (iii) includes a defendable space around the perimeter being a minimum 20 metres to the north, and 11 metres from all other directions, that permits unobstructed vehicle access; and
 - (iv) is managed as an asset protection zone (including the defendable space);

- (c) assist the RFS, FRNSW and emergency services as much as practicable if there is a fire in the vicinity of the site; and
- (d) notify the relevant local emergency management committee following completion of construction of the development, and prior to commencing operations.

Emergency Plan

- B40. Prior to commencing construction of the solar farm (including the accommodation camp and battery storage facility), the Applicant must develop and implement a comprehensive Emergency Plan and detailed emergency procedures for the development, including an evacuation plan for the accommodation camp, and provide a copy of the plan to the local Fire Control Centre and FRNSW. The plan must:
 - (a) be prepared in accordance with the findings of the Fire Safety Study required under Condition B35 of Schedule 2:
 - (b) be consistent with Department's Hazardous Industry Planning Advisory Paper No. 1, 'Emergency Planning' and RFS's Planning for Bushfire Protection 2019 (or equivalent);
 - (c) be consistent with the NSW RFS document: A Guide to Developing a Bush Fire Emergency Management and Evacuation Plan.
 - (d) include details on how the battery storage and sub-systems can be safely isolated in an emergency;
 - (e) identify the fire risks and hazards and detailed measures for the development to prevent fires igniting;
 - (f) include availability of fire suppression equipment, access and water;
 - (g) detail access provisions for emergency vehicles and contact details for both a primary and alternative site contact who may be reached 24/7 in the event of an emergency;
 - (h) include fire and bushfire emergency management planning, including:
 - (i) details of the location, management and maintenance of the Asset Protection Zone;
 - (ii) a list of works that must not be carried out during a total fire ban;
 - (iii) details of how RFS would be notified, and procedures that would be implemented in the event that:
 - there is a fire on-site or in the vicinity of the site;
 - there are any activities on site that would have the potential to ignite surrounding vegetation; or
 - there are any proposed activities to be carried out during a bushfire danger period;
 - (i) detail specific response measures in the case of flood or fire to ensure human and site safety;
 - (j) describe the specific emergency exit routes to be used in the case of flood or fire, and include evidence of access agreements with relevant landowners (e.g. right of carriageway); and
 - (k) include an Emergency Services Information Package in accordance with *Emergency services* information package and tactical fire plan (FRNSW, 2019), to the satisfaction of FRNSW and RFS.

B41. The Applicant must:

- (a) implement the Emergency Plan and Emergency Services Information Package for the duration of the development; and
- (b) following commencement of commissioning of the battery storage, keep two copies of the Emergency Plan and Emergency Services Information Package on-site in a prominent position adjacent to the site entry points at all times.

ACCOMMODATION CAMP

- B42. Unless the Planning Secretary agrees otherwise, the applicant must construct and operate the accommodation camp as described in the EIS and in Appendix 1 of this consent, prior to commencing all other construction activities.
- B43. Prior to commencing construction of the accommodation camp, the Applicant must prepare an Accommodation Camp Management Plan in consultation with Mid-Western Regional Council and Warrumbungle Shire Council. Unless the Planning Secretary agrees otherwise, the plan must:
 - (a) ensure utilities at the accommodation camp, including water, wastewater, waste and electricity, are designed and located in accordance with Mid-Western Regional Council specifications and relevant standards:
 - (b) include a schedule of proposed materials, colours and finishes for all proposed buildings and structures (noting that colours should, where practicable comprise of muted tones complimentary with the surrounding rural landscape and materials must be non-reflective);
 - (c) ensure the accommodation camp complies with conditions B33 and B39;

- ensure any treated wastewater from the accommodation camps used for dust suppression during construction;
 - (i) complies with the Australian and New Zealand Environment and Conservation Council (ANZECC) and Agriculture and Resource Management Council of Australia and New Zealand (ARMCANZ) (2000) Guidelines for irrigation water quality;
 - (ii) meets the requirements of the Public Health Act 2010;
- (e) include measures for dust suppression within the accommodation camp;
- (f) provide the site layout including building locations, vehicle access, parking and movement, site servicing and utilities infrastructure; and
- (g) include measures to support local suppliers in servicing the camp where possible.

The Applicant must implement the Accommodation Camp Management Plan.

B44. Prior to the accommodation camp becoming operational, the Applicant must notify the Western NSW Local Health District of final health services provided for the camp's occupants.

ACCOMMODATION AND EMPLOYMENT STRATEGY

- B45. Prior to commencing construction, the Applicant must prepare an Accommodation and Employment Strategy for the development in consultation with Mid-Western Regional Council and Warrumbungle Shire Council. This strategy must:
 - (a) propose measures to ensure there is sufficient accommodation for the workforce associated with the development, generally consistent with the draft Accommodation and Employment Strategy dated 11 December 2023;
 - (b) consider the cumulative impacts associated with other State significant projects in the area;
 - (c) investigate options for prioritising the employment of local workers for the construction and operation of the development, where feasible; and
 - (d) include a program to monitor and review the effectiveness of the strategy over the life of the development, including the timing for regular monitoring, reporting of outcomes and review during construction.

The Applicant must provide a copy of the Accommodation and Employment Strategy to the Planning Secretary prior to commencement of construction, and implement the plan throughout construction and operation of the accommodation camp. All reporting must be published on the Applicant's website as soon as practicable after finalisation of reports.

WASTE

- B46. The Applicant must:
 - (a) minimise the waste generated by the development;
 - (b) classify all waste generated on site in accordance with the EPA's *Waste Classification Guidelines* 2014 (or its latest version);
 - (c) store and handle all waste on site in accordance with its classification;
 - (d) not receive or dispose of any waste on site; and
 - (e) remove all waste from the site as soon as practicable, and ensure it is reused, recycled or sent to an appropriately licensed waste facility for disposal.

DECOMMISSIONING AND REHABILITATION

B47. Unless the Planning Secretary agrees otherwise, within 12 months of commencing operation of the project, the applicant must decommission and rehabilitate the accommodation camp to the satisfaction of the Planning Secretary. This rehabilitation must comply with the objectives in Table 5.

PART C ENVIRONMENTAL MANAGEMENT AND REPORTING

ENVIRONMENTAL MANAGEMENT

Environmental Management Strategy

- C1. Prior to commencing construction, the Applicant must prepare an Environmental Management Strategy for the development to the satisfaction of the Planning Secretary. This strategy must:
 - (a) provide the strategic framework for environmental management of the development;
 - (b) identify the statutory approvals that apply to the development;
 - (c) describe the role, responsibility, authority and accountability of all key personnel involved in the environmental management of the development;
 - (d) include an ongoing community communication plan that describes the procedures that would be implemented to:
 - keep the local community and relevant agencies informed about the operation and environmental performance of the development, including how often and when information would be made available;
 - (ii) receive, handle, respond to, and record complaints;
 - (iii) resolve any disputes that may arise;
 - (iv) respond to any non-compliance;
 - (v) respond to emergencies; and
 - (e) include:
 - references to any strategies, plans and programs approved under the conditions of this consent; and
 - (ii) a clear plan depicting all the reviewing and monitoring to be carried out in relation to the development.

Following the Planning Secretary's approval of the Environmental Management Strategy, the Applicant must implement the Environmental Management Strategy.

Revision of Strategies, Plans and Programs

- C2. The Applicant must:
 - (a) update the strategies, plans or programs required under this consent to the satisfaction of the Planning Secretary prior to carrying out any upgrading or decommissioning activities on site; and
 - (b) review and, if necessary, revise the strategies, plans or programs required under this consent to the satisfaction of the Planning Secretary within 1 month of the:
 - (i) submission of an incident report under condition C10 of Schedule 2;
 - (ii) submission of an audit report under condition C14 of Schedule 2; or
 - (iii) any modification to the conditions of this consent.

Updating and Staging of Strategies, Plans or Programs

- C3. With the approval of the Planning Secretary, the development may be staged and the Applicant may:
 - (a) prepare and submit any strategy, plan or program required by this consent on a staged basis (if a clear description is provided as to the specific stage and scope of the development to which the strategy, plan or program applies, the relationship of the stage to any future stages and the trigger for updating the strategy, plan or program);
 - (b) combine any strategy, plan or program required by this consent (if a clear relationship is demonstrated between the strategies, plans or programs that are proposed to be combined); and
 - (c) update any strategy, plan or program required by this consent (to ensure the strategies, plans and programs required under this consent are updated on a regular basis and incorporate additional measures or amendments to improve the environmental performance of the development).
- C4. If the Planning Secretary agrees, a strategy, plan or program may be staged or updated without consultation being undertaken with all parties required to be consulted in the relevant condition in this consent.
- C5. If approved by the Planning Secretary, updated strategies, plans or programs supersede the previous versions of them and must be implemented in accordance with the condition that requires the strategy, plan or program.
- C6. If the Planning Secretary agrees, a strategy, plan or program may be staged without addressing particular requirements of the relevant condition of this consent if those requirements are not applicable to the particular stage.

NOTIFICATIONS

Notification of Department

C7. Prior to commencing the construction, operations, upgrading or decommissioning of the development or the cessation of operations, the Applicant must notify the Department in writing via the Major Projects website portal of the date of commencement, or cessation, of the relevant phase.

If any of these phases of the development are to be staged, then the Applicant must notify the Department in writing prior to commencing the relevant stage, and clearly identify the development that would be carried out during the relevant stage.

Final Layout Plans

- C8. Prior to commencing construction, the Applicant must submit detailed plans of the final layout of the development to the Department via the Major Projects website, including details on the siting of solar panels and ancillary infrastructure. The final design and layout of the battery storage system must include the following information:
 - (a) site plan(s);
 - (b) elevations;
 - a schedule of proposed materials, colours and finishes (noting that colours should, if practicable comprise of muted tones complimentary with the surrounding rural landscape and materials must be non-reflective);
 - (d) a stormwater drainage report and plans prepared by suitably qualified and practicing hydraulic engineer, consistent with the conditions of this consent; and
 - (e) design details that demonstrate consideration of articulation, modulation and visual screening.

The Applicant must ensure that the development is constructed in accordance with the Final Layout Plans.

Work as Executed Plans

C9. Prior to commencing operations or following the upgrades of any solar panels or ancillary infrastructure, the Applicant must submit work as executed plans of the development to the Department via the Major Projects website.

Incident Notification

C10. The Planning Secretary must be notified in writing via the Major Projects website immediately after the Applicant becomes aware of an incident. The notification must identify the development (including the development application number and the name of the development if it has one) and set out the location and nature of the incident. Subsequent notification requirements must be given, and reports submitted in accordance with the requirements set out in Appendix 8.

Non-Compliance Notification

- C11. The Department must be notified via the Major Projects website portal within seven days after the Applicant becomes aware of any non-compliance.
- C12. A non-compliance notification must identify the development and the application number for it, set out the condition of consent that the development is non-compliant with, the way in which it does not comply and the reasons for the non-compliance (if known) and what actions have been, or will be, undertaken to address the non-compliance.
- C13. A non-compliance which has been notified as an incident does not need to also be notified as a non-compliance.

INDEPENDENT ENVIRONMENTAL AUDIT


- C14. Independent Audits of the development must be conducted and carried out in accordance with the Independent Audit Post Approval Requirements (2020).
- C15. In accordance with the specific requirements in the *Independent Audit Post Approval Requirements* (2020), the Applicant must:
 - (a) review and respond to each Independent Audit Report prepared under condition C14 of Schedule 2 of this consent, or where notice is given by the Planning Secretary;
 - (b) submit the response to the Planning Secretary; and
- C16. make each Independent Audit Report, and response to it, publicly available within 60 days of submission to the Planning Secretary. Independent Audit Reports and the Applicant's response to audit findings must be

- submitted to the Planning Secretary within 2 months of undertaking the independent audit site inspection as outlined in the *Independent Audit Post Approval Requirements* (2020) unless otherwise agreed by the Planning Secretary.
- C17. Notwithstanding the requirements of the *Independent Audit Post Approval Requirements* (2020), the Planning Secretary may approve a request for ongoing independent operational audits to be ceased, where it has been demonstrated to the Planning Secretary's satisfaction that independent operational audits have demonstrated operational compliance.

ACCESS TO INFORMATION

- C18. The Applicant must:
 - (a) make the following information publicly available on its website as relevant to the stage of the development as soon as possible and within 5 business days:
 - (i) the EIS;
 - (ii) the final layout plans for the development;
 - (iii) current statutory approvals for the development;
 - (iv) approved strategies, plans or programs required under the conditions of this consent (other than the Fire Safety Study and Emergency Plan);
 - the proposed staging plans for the development if the construction, operation or decommissioning of the development is to be staged;
 - (vi) how complaints about the development can be made;
 - (vii) a complaints register;
 - (viii) compliance reports;
 - (ix) any independent environmental audit, and the Applicant's response to the recommendations in any audit; and
 - (x) any other matter required by the Planning Secretary; and
 - (b) Provide construction progress updates on its website at appropriate construction milestones, including identification of any delays; and
 - (c) keep this information up to date.

APPENDIX 3: INDICATIVE SUBDIVISION PLAN







APPENDIX 7: REQUIREMENTS FOR STRATEGIC CONCEPT DESIGN

- 1. Revise the strategic concept design to include consideration of an Austroads compliant radii. The road design should smooth out the edge of the median to achieve a radii that provides a through lane alignment keeping with the 85th percentile speed 100km/h for south bound traffic.
- 2. Updated swept paths diagrams for the design heavy vehicle requiring escort at the intersection of Barneys Reef Road/Castlereagh Highway, which show that the turning arc of the design vehicle can be delivered within the pavement extents of the proposed road upgrades.

Note: If the revised strategic concept design demonstrates that the required intersection exceeds the area of the approved intersection design in Appendix 5, the applicant must ensure that all relevant approvals are obtained (including any landowners consent).

APPENDIX 8: INCIDENT NOTIFICATION AND REPORTING REQUIREMENTS

WRITTEN INCIDENT NOTIFICATION REQUIREMENTS

- A written incident notification addressing the requirements set out below must be submitted to the Planning Secretary via the Major Projects website within seven days after the Applicant becomes aware of an incident. Notification is required to be given under this condition even if the Application fails to give the notification required under condition C10 of Schedule 2 or, having given such notification, subsequently forms the view that an incident has not occurred.
- 2. Written notification of an incident must:
 - (a) identify the development and application number;
 - (b) provide details of the incident (date, time, location, a brief description of what occurred and why it is classified as an incident);
 - (c) identify how the incident was detected;
 - (d) identify when the applicant become aware of the incident;
 - (e) identify any actual or potential non-compliance with conditions of consent;
 - (f) describe what immediate steps were taken in relation to the incident;
 - (g) identify further action(s) that will be taken in relation to the incident; and
 - (h) identify a project contact for further communication regarding the incident.
- 3. Within 30 days of the date on which the incident occurred or as otherwise agreed to by the Planning Secretary, the Applicant must provide the Planning Secretary and any relevant public authorities (as determined by the Planning Secretary) with a detailed report on the incident addressing all requirements below, and such further reports as may be requested.
- 4. The incident report must include:
 - (a) a summary of the incident;
 - (b) outcomes of an incident investigation, including identification of the cause of the incident;
 - (c) details of the corrective and preventative actions that have been, or will be, implemented to address the incident and prevent recurrence; and
 - (d) details of any communication with other stakeholders regarding the incident.
