CHAIR'S OVERVIEW

2019-20 has been an important year for the Independent Planning Commission.

Review of IPC

The Independent Planning Commission has undergone substantial transformation to its operations and structure over the year. This follows a comprehensive Review of the IPC by the NSW Productivity Commissioner which reaffirmed the value of having an independent decision-making body for contentious state significant development.

That Review followed a series of high-profile determinations, which drew criticism from key industry and stakeholder groups.

We've worked diligently to implement the Review's recommendations to build confidence in the Commission and the decisions it makes still further.

The most significant reforms, which seek to strengthen the Commission's independence and governance and improve its overall performance – including establishing the Office of the IPC as a separate agency under the *Government Sector Employment Act 2013* and installing the Chair as agency head – have already been implemented.

Some of the other reforms, including technological changes to support improved processes and efficiency, are ongoing.

Minister's Statement of Expectations

In May, the Minister for Planning and Public Spaces provided his new Statement of Expectations to the Commission. It outlines his expectations in relation to the purpose, functions and roles of the Commission, as well as key governance and performance objectives in determining SSD applications.

Notably, it sets new timeframes for decision-making ranging from five weeks (35 days) for 'routine' determinations, to eight weeks (56 days) for determinations requiring a public meeting, and 12 weeks (84 days) for determinations requiring a public hearing. Requests for advice need to be completed within five weeks (35 days).

Commissioners

Thirty-three Commissioners served on the IPC in 2019-20: 22 men and 11 women.

There were no new appointments to the Commission during that period; however, six Commissioners came to the end of their terms: Mr Alan Coutts, Mr George Gates, Mr Gordon Kirkby, Ms Robyn Kruk AO (resignation), Dr Ian Lavering and Associate Professor Brett Whelan.

I thank them for their dedicated service to the Commission and the people of NSW and wish them well for their future endeavours.

Caseload

The Commission's caseload was down considerably on the previous year. In 2019-20, the Commission completed 54 cases (compared to 65 in 2018-19), including:

- the determination of 43 SSD and modification applications
- 11 pieces of advice.

Some of the contentious cases considered by the Commission included the Bylong Coal Project, Star Casino Ritz Carlton development, United Wambo Open Cut Coal Mine Project, Rix's Creek Coal Mine Extension and the New England Solar Farm.

The Commission approved SSD with capital investment value of at least \$4.25 billion and projected to create more than 15,404 construction and operational jobs in 2019-20.



Community consultation

The Commission introduced its Community Participation Plan in November last year which sets out when and how the community can participate in our processes. In adopting this Plan, we continue to acknowledge the importance of ongoing consultation with our stakeholders to ensure the Commission's decision-making processes remain inclusive, representative and considerate of the diversity of views within the community.

We held public meetings for 11 cases – including our first ever electronic public meeting (EPM) for the Brandy Hill Quarry Expansion Project.

In light of strict bans on public gatherings and social distancing guidelines introduced in response to the COVID-19 (Coronavirus) pandemic, the Commission found new ways to engage with interested individuals and/or groups and ensure their views could still be heard.

The Brandy Hill EPM, which involved Commissioners hosting livestreamed proceedings from a broadcast studio and registered speakers presenting to the Panel via videoconference or telephone, was very successful and is the model for public hearings and meetings for the foreseeable future.

Moving forward

It's been an incredibly busy and, at times, challenging year for the Commission.

I would like to thank my colleagues on the Commission and the staff within the Office of the IPC for their hard work over the past 12 months. I would particularly like to thank Mr Peter Duncan AM for his wonderful leadership as Acting Chair of the Commission whilst I was co-leading the NSW Bushfire Inquiry for the first half of 2020; as well as Dr Sam McLean, Executive Director, Office of the IPC, for her leadership through a period of great change.

We're working as a team to strengthen the culture of excellence and continuous improvement within the Commission. Embracing new performance benchmarks, streamlining processes and ensuring greater accountability is, we believe, key to establishing the Commission as an exemplar consent authority which is trusted by government, industry and the community to make planning decisions in the best interests of NSW and its people.

WHO WE ARE

CHARTER

The Independent Planning Commission of NSW was established under the *Environmental Planning and Assessment Act 1979* on 1 March 2018 as a consent authority for state significant development in New South Wales.

The Commission is not subject to direction or control of the Minister for Planning and Public Spaces or any government agency, except in relation to procedural matters as set out under the *Environmental Planning and Assessment Act 1979.*

The Commission has a Statement of Expectations from the Minister.

FUNCTION

The key functions of the Independent Planning Commission are to:

- determine State significant development applications where there is significant opposition from the community
- conduct public hearings for development applications and other planning and development matters, or
- provide independent advice on any planning matter (but not development applications), when requested by the Minister for Planning and Public Spaces or Secretary of the Department of Planning, Industry and Environment.

The Commission as a consent authority

The State's planning laws clearly identify which State significant development applications are to be determined by the Independent Planning Commission and which are delegated to the Department of Planning, Industry and Environment (the Department) to determine.

The Independent Planning Commission is the consent authority for State significant development applications in circumstances where:

- there are 50 or more 'unique' public objections to the SSD application, and/or
- the Applicant has disclosed a reportable political donation, and/or
- the local Council has objected to the SSD

application and has not rescinded that objection following exhibition.

In circumstances where a Council has rescinded its objection following exhibition of the application – and Council's objection was the only reason for the Commission to be the consent authority – the SSD application would be delegated back to the Department for determination.

The Commission will also continue to be the consent authority for modification applications in circumstances where the applicant has disclosed a reportable political donation. All other modification applications will be delegated to the Department for determination.

The Commission will independently determine each application on its individual merits and in accordance with legislation and current government policy.

PURPOSE

To provide high quality determinations and advice that meet the objects of the *Environmental Planning and Assessment Act 1979*, build and maintain trust in the NSW planning system, and deliver on the following objectives:

- independent and objective decision making
- openness and transparency in the operations of the Office of the Commission
- delivering robust and timely determinations within the legislative and Government policy framework to best serve the people of NSW
- encouraging effective community and other stakeholder participation to inform Commission determinations and advice.

VALUES

The Commission's values are reflected in the way its members and staff act and carry out their duties.

Independence – Commissioners are independent and objective in the decisions they make and advice they provide. The Office of the Independent Planning Commission is separate from other government departments and agencies.





REVIEW OF THE COMMISSION

About the Review

In October 2019, the Minister for Planning and Public Spaces, the Hon Rob Stokes MP, asked the state's Productivity Commissioner to conduct a review of the Independent Planning Commission NSW. This followed an administrative error by the Commission in announcing its determination of the Rix's Creek South Continuation of Mining Project before the formal consultation period had closed.

Mr Peter Achterstraat AM finalised his Review in December 2019, which examined, among other things, whether it is in the public interest to maintain an Independent Planning Commission and the operations and processes of the Commission in the State's planning framework.

On 1 February 2020, the Minister announced the NSW Government had accepted all the Review's recommendations – and that key changes to the Commission would include:

- establishing the Office of the Commission as a separate and independent agency, with its chair accountable to the Minister for Planning and Public Spaces and responsible for delivering on the Government's agreed objectives and performance measures
- clarifying roles with the Commission to act as a decision-maker on the State's most controversial projects rather than re-assessing the Department's technical work
- eliminating bureaucratic double handling with the introduction of a single-stage public hearing process
- ensuring only the most complex and contentious projects are referred to the Commission by raising the referral threshold to 50 unique community objections, and
- introducing accountability benchmarks for decision-making timeframes to ensure timely determinations.

Following the Review


Acting Commission Chair, Mr Peter Duncan AM, led the implementation of the recommendations from the Review. Mr Duncan was acting Chair of the Commission while Professor Mary O'Kane AC headed up an independent inquiry into the catastrophic 2019-2020 bushfire season alongside former NSW Police Force Deputy Commissioner Dave Owens PSM.

Mr Duncan is a long-serving Commissioner of the IPC and a former Chief Executive of Roads and Maritime Services, Director-General of the Department of Services Technology and Administration NSW, and Deputy Director General of the Department of Premier and Cabinet.

Mr Duncan welcomed the Review's findings and committed to implementing the recommendations in full to build confidence in the Commission and the decisions it makes.

REVIEW OF COMMISSION

Office of the Independent Planning Commission NSW

The Office of the Independent Planning Commission (OIPC) was set up as a separate agency under the *Government Sector Employment Act 2013* on 1 July 2020. This was in direct response to Recommendation 2 of the Productivity Commissioner's Review of the IPC.

The OIPC provides professional and technical support to the Commission and its members. It is the main point of contact for the public and Government agencies.

The OIPC coordinates and facilitates the Commission's decision-making processes and aims to provide efficient, transparent and high-performing support services.

Minister's Statement of Expectations

On 14 May 2020, the Minister published his *Statement of Expectations for the Commission*.

The document describes the Minister's expectations in relation to the purpose, functions and roles of the Commission, as well as key governance and performance objectives to improve the effectiveness of the Commission in determining contentious State significant development applications and providing independent expert advice, when required.

This Statement of Expectations applies for the period from 1 May 2020 to 30 June 2021, or until otherwise amended.

Memorandum of Understanding with the Department of Planning, Industry & Environment

Both the Planning and Assessments Group within the Department and the Commission undertake functions that implement the *Environmental Planning and Assessment Act 1979*.

A new Memorandum of Understanding (MoU) between the Department and Commission has been signed to clarify how the two agencies will work together when required under the Act to interact, in order to exercise their responsibilities with an emphasis on quality, probity, timeliness and transparency.

This MoU is subject to the responsibilities of the Department and the Commission under the Act and anyother NSW legislation.other NSW legislation.

CONSTITUTION OF THE COMMISSION

Members of the Commission are appointed by the Minister for Planning and Public Spaces based on their qualifications and considerable expertise in a diverse range of fields. One member is appointed as the Chair of the Commission.

Under section 2.8 of the *Environmental Planning and* Assessment Act 1979:

"Each member is to have expertise in at least one area of planning, architecture, heritage, the environment, urban design, land economics, soil or agricultural science, hydro-geology (sic), mining or petroleum development, traffic and transport, law, engineering, tourism or government and public administration.

In appointing a member of the Commission, the Minister is to have regard to the need to have a range of expertise represented among the Commission's members.

The Minister may appoint additional members of the Commission for the purposes of exercising specific functions of the Commission. An additional member is not required to have expertise in an area referred to in this section but is required to have expertise in an area relevant to the functions the member is to exercise."

Members are individually appointed for terms of up to three years and cannot serve more than six years in total.

Constitution of the Commission for each matter

The Chair of the Commission appoints members to constitute the Commission for each case.

When appointing Members to a Panel to determine a particular development application or provide advice on a planning matter, the Chair will ordinarily take the following matters into account:

 (where possible) ensuring gender balance on panels, particularly for matters where a public meeting or public hearing are being held, and



- ensuring there is a balance of Members with:
 - governance skills, including leadership
 experience
 - a good understanding of the NSW planning process (including the *Environmental Planning and Assessment Act*).

Generally, the Chair will appoint:

- at least two members, for:
 - the carrying out of a public hearing
 - the determination of a development application,or
 - the making of a local environmental plan
- at least one member, for:
 - the determination of a modification application
 - preparing advice to the Minister for Planning and Public Spaces or Secretary of the Department of Planning, Industry and Environment
- the same members to determine an application that were appointed to carry out a public hearing for it unless they are unavailable for any reason, in accordance with the Ministerial Direction (18 October 2013)

According to the Act: "the Chair of the Commission is authorised to nominate another member of the Commission to appoint members to constitute the Commission for a matter – and may do so, as required, for any reason."

Commissioners in 2019-20

There were no new Commissioners appointed in 2019-20; however, six Commissioners' terms ended in the reporting period: Mr Alan Coutts, Mr George Gates, Mr Gordon Kirkby, Ms Robyn Kruk AO (resigned), Dr Ian Lavering and Mr Brett Whelan.

As at 30 June 2020, there was a total of 27 Commissioners – 33% of the Commissioners were female.

Table 2 provides the names of Commission Membersand their lengths of service.

The Mining and Petroleum Gateway Panel remains a sub-committee of the Commission.

Managing Conflicts

The Commission strives to be independent, informed, consistent and transparent it its decision-making processes. Accordingly, it maintains a high standard of Conflict of Interest disclosure both in general and with reference to cases being dealt with by the Commission. Full details are provided on the Commission's website.

Commissioner Induction and Meetings

The Commission provides an induction pack and specialised training for new Members to explain the Commission's organisational structure, policies and procedures, and day-to-day operations.

Commission Members meet quarterly to discuss issues arising from recent projects, lessons learned, planning issues and policies relevant to their work. Briefings on policy developments and training on specialised aspects of the Commission's operations are also provided at these meetings.

PERFORMANCE

Caseload

In 2019-20, the Commission worked on a total of 57 cases – 39 new referrals and 18 cases carried forward from the previous financial year: The Commission's caseload comprised:


- 44 State Significant Development (SSD) applications, including modification applications, for determination
- two determinations with public hearings for the Vickery Extension Project (second and final stage of a multistage public hearing) and the Narrabri Gas Project
- 11 requests for advice on planning proposals and other planning-related matters

The chart in **Figure 2** shows the breakdown of new Commission cases by statutory function in 2019-20.




Figure 3 Changing caseload: 2008 to present.

Figure 3 reveals the number of new cases referred to the Commission was down $^{\sim}49\%$ year on year.

The bulk of the new referrals were development applications (including modifications) for determination (77%), followed by requests for advice (18%) and public hearings (5%).

Figure 2 Breakdown of new case referrals to Commission by statutory function 2019-20.


Figure 4 Case determinations by outcome 2019-2020.

The Commission completed a total of 54 cases in 2019-20. Of the 43 SSD and modification applications determined by the Commission during the reporting period **(Figure 4):**

- seven were approved in accordance with the Department's recommendations
- 32 were approved in accordance with the Department's recommendations except the Commission made changes to the Department's recommended conditions of consent, while
- two were refused in accordance with the Department's recommendations, and
- two were refused contrary to the Department's recommendations.


The Minister requested the Commission hold public hearings as part of its determination of two SSD applications referred in 2019-20: the Vickery Extension Project (SSD 7480) and the Narrabri Gas Project (SSD 6456). These matters were still under consideration by the Commission as at 30 June 2020.

The Commission finalised 11 pieces of advice on planning proposals and planning-related matters in 2019-20.

The chart in **Figure 5** shows the status of Commission cases at 30 June 2020

PERFORMANCE




Figure 6 How the flow of cases to Commission has changed over time.

As previously mentioned, the number of cases referred to the Commission in 2019-20 was down markedly on recent years. After a rush of new cases at the start of the reporting period, **Figure 6** shows the Commission received only a handful of referrals each month between September and March.

PERFORMANCE

Public Hearings & Meetings

Community participation is integral to the decision-making processes of the Commission as a consent authority for state significant development. Public hearings and meetings provide the Commission a tremendous opportunity to hear the community's views about SSD applications, and, particularly, the Department's whole-of-government assessment of those applications and any recommended conditions of consent.

Under the Act, the Minister may formally ask the Commission to hold a public hearing in relation to a development application or any other planning matter at any time. If such a request is made, the Commission must hold a public hearing.

When the Commission, at the request of the Minister, holds a public hearing (including a multistage public hearing) in relation to an SSD application for which it is the consent authority, merit appeal rights in respect of any future decision on that application are extinguished.

The Act does not require the Commission to hold a public meeting before determining other SSD applications; however, the Commission may elect to hold a public meeting if there is significant interest in a case.

The Commission quickly adopted innovative technological solutions to challenges posed by strict requirements for social distancing and bans on public gatherings introduced in response to the COVID-19 (Coronavirus) pandemic. Under its new model for Electronic Public Hearings and Meetings, the Commission will for the foreseeable future host the livestreamed events from a central broadcast studio with stakeholders presenting to the Panel via videoconference or telephone. These new processes have been designed to maximise inclusiveness and opportunities for representation in an open and transparent way, recognising the importance of understanding differences of opinion on matters before the Commission – although with the compromising on speaker timing, as noted under 'Changes to Public Hearings and Public Meetings during COVID-19 pandemic' later in this Report.

This aligns with the *Environmental Planning and Assessment Amendment (COVID-19 Planning Bodies) Regulation 2020,* introduced on 30 April 2019, requiring planning bodies, including the Commission, to conduct public hearings and public meetings by electronic means. Under the regulation, a public hearing or public meeting must:

- be held by means of an audio link or audiovisual link, and
- be able to be heard or viewed by electronic means by a member of the public at the time it is held.

As shown in **Table 3**, the Commission held 10 public meetings in 2019-20, including its first ever EPM for the Brandy Hill Quarry Expansion Project. Preparations were also well advanced for the Vickery Extension Project and Narrabri Gas Project EPHs as at 30 June 2020.

PERFORMANCE

Timeframes

The Commission's average processing time for determinations with a public meeting was 108 calendar days in 2019-20, up 11% on 2018-19. Cases that did not require a public meeting were finalised much faster.

The average processing time for projects referred to the Commission for determination because a local council had objected was 35 (-17%) calendar days; while it took the Commission, on average, 35 (-31%) calendar days to determine projects which had been referred to it because there had been a reportable political donation.

No public hearings were completed during the reporting period.

The Commission's average processing time for advice matters (not requiring a public meeting) was 47 (-36%) calendar days.


The former Minister for Planning also referred two contentious cemetery proposals at Varroville, in Sydney's southwest, and Wallacia, in Sydney's west, to the Commission for its consideration. The Minister delegated to the Commission his function under Division 4.6 of the Act to provide a direction to the Planning Panel. The Commission referred both development applications to the Department for further assessment. After receiving the Department's final assessment reports, the Commission held public meetings to listen to the community's views. Having considered all the evidence, the Commission then directed the Sydney Western City Planning Panel to approve the proposed Varroville development and refuse the proposed Wallacia development. Due to the complex nature of these two cases, the average processing time was 378 days.

Figure 7 shows the average processing time for cases by function type in 2019-20.

New KPIs for Decision-making

The Minister's Statement of Expectations, which took effect on 1 May 2020, introduced new key performance indicators to ensure ongoing timeliness and quality of the Commission's decisions. In meeting these timeframes, the Minister has acknowledged that the Department also has an obligation to ensure the Commission is made aware of upcoming matters,

provide adequate assessment documentation and respond to information requests in a timely manner, in accordance with the Memorandum of Understanding between the Department and the Commission.

State Significant Development Determinations

From the date of the provision of the Department's Assessment Report (excluding any time where the Commission has requested further information from the Department or the Applicant), the Commission is now expected to meet (as an annual rolling average) the following timeframes for determination:

- five weeks (35 calendar days) for routine determinations (no public meeting or hearing) and modifications with political donations
- eight weeks (56 calendar days) for determinations subject to a public meeting, and
- 12 weeks (84 calendar days) for determinations subject to a public hearing.

The Commission was referred three cases post 1 May 2020 that were required to be determined within the new timeframes set out above. One case, which included a public meeting, was determined in 55 calendar days, while two other 'routine' determinations were made in 29 and 34 days respectively.

Gateway and Rezoning Reviews

The Commission is expected to provide its advice to the Planning Secretary within:

 five weeks (35 calendar days) including any meetings and preparation of the advice (unless otherwise agreed with the Planning Secretary and excluding any time where the Commission has requested further information from the Department, Council or the Applicant)

The Commission received one request for advice post 1 May 2020 which was subject to the new KPIs. That request was completed in 23 days, 12 days ahead of schedule.

Mining and Petroleum Gateway Certificates


Timeframes for the determination of Gateway Certificate Applications are specified in *State Environmental Planning Policy (Mining, Petroleum Production and Extractive Industries) 2007.* In meeting these timeframes, the Minister has acknowledged the Department also has an obligation to ensure the Commission is made aware of upcoming matters, provide adequate assessment documentation and respond to information requests in a timely manner, in accordance with the Memorandum of Understanding between the Department and the Commission.

Location of Cases

The Commission's work has again been spread right across New South Wales, although more of that work has been focussed on metropolitan Sydney than in recent years.

Of the 57 cases the Commission worked on in 2019-20, 36 were in the Sydney metropolitan area and 21 were in regional and rural NSW. The chart in **Figure 8** shows this breakdown.

Type of cases




Figure 9 The Commission's caseload by type and function 2019-20

The Commission has worked on a diverse range of cases in 2019-20. As shown in **Figure 9**, these cases generally fall into one of the following categories:

- resources (e.g. gas extraction, mining)
- urban development (Sydney Metro or Regional/Rural)
- industrial
- infrastructure (e.g. solar farm, wind farm, gas pipeline, hospital, schools)
- other (eg. cultural)






Figure 10 The Commission's caseload by LGA and type 2019-20

The Commission's work has focussed on 31 NSW local government areas in 2019-20, as shown in Figure 10.

POLICIES AND PROCEDURES

The Commission undertakes regular consultation and engagement with key stakeholders, including state and local government, industry bodies and environmental action groups, to seek their input on how it could improve its policies and processes to build community confidence in the decisions it makes.

As a direct result of their constructive feedback, the Commission has refined a number of its policies with the aim of being more open and transparent, including its:

- Community Participation Plan
- Public Hearing Guidelines
- Meeting Record Policy
- Privacy Statement
- Additional Material Policy

Changes to Public Hearings and Public Meetings during COVID-19 pandemic

Community participation is integral to the decisionmaking processes of the Commission.

For this to continue during the COVID-19 (Coronavirus) pandemic – considering strict bans on public gatherings and social distancing requirements – the Commission moved quickly to adopt innovative new ways to engage with interested individuals and/or groups and ensure their views on complex and contentious development applications were heard

In line with regulations introduced in response to the pandemic, the Commission moved its public meetings and hearings online. Commissioners hosted what were previously 'town hall-style' events from a broadcast studio with registered speakers presenting via telephone or videoconference. In the interests of openness and transparency, proceedings were livestreamed, and full transcripts published on the Commission's website.

This online form of community consultation has worked very well, although it has involved some temporary compromises, such as reverting to fixed time for speakers, typically of between five and 15 minutes. This is a matter that the Auditor-General for NSW had criticised in a report in 2017. Post-COVID, the Commission will revert to its practice introduced in 2018 in response to the Auditor-General's comments of allowing speakers to (within reason) nominate how long they would like to speak.

FINANCES

The Department of Planning, Industry & Environment managed the Commission's finances in 2019-20. The Department's audited financial statements include the Commission.

GIPA ACT REQUESTS

The Commission received one formal request under the *Government Information (Public Access) Act 2009* during 2019-20. See **Table 4**.

COMPLAINTS

The Commission appreciates public feedback on its processes and considers them carefully in accordance with its '*Complaints Management Policy*', available on its website.

It should be noted that objections to a development proposal or comments on the outcome of a project are not considered as formal complaints for complaints handling and management purposes. Rather they are dealt with as part of the applicable determination or advice process that applies to the relevant matter. The Commission received three formal complaints in 2019-20. See **Table 5**.

PRIVACY

The Commission's 'Privacy Statement' is published on its website. The statement explains how the Commission obtains and uses personal information.

LEGAL PROCEEDINGS

There were a number of legal actions in relation to determinations made by the Commission which were commenced in 2019-20. See **Table 6**.




