



## **NOTICE OF PLANNING ASSESSMENT COMMISSION MEETING** ***Cabbage Tree Road Sand Quarry- D500-18***

The Department of Planning and Environment (DP&E) has completed its assessment of the above proposal. The application has been referred to the Planning Assessment Commission (the Commission) for determination, under the terms of the Minister's delegation.

The Commission to determine the application comprises Ms Dianne Leeson (chair), Mr Peter Duncan AM and Mr Peter Cochrane.

Due to the level of public interest in the proposal, the Commission will be meeting to hear public views on the Assessment Report and recommendation, prior to determining the proposal. This is a final opportunity for interested parties to comment on the DP&E's assessment and proposed conditions of approval, before a decision is made.
