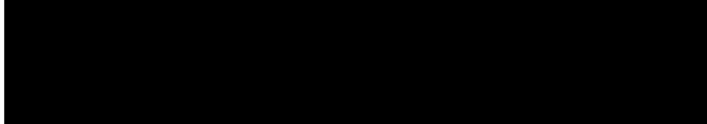

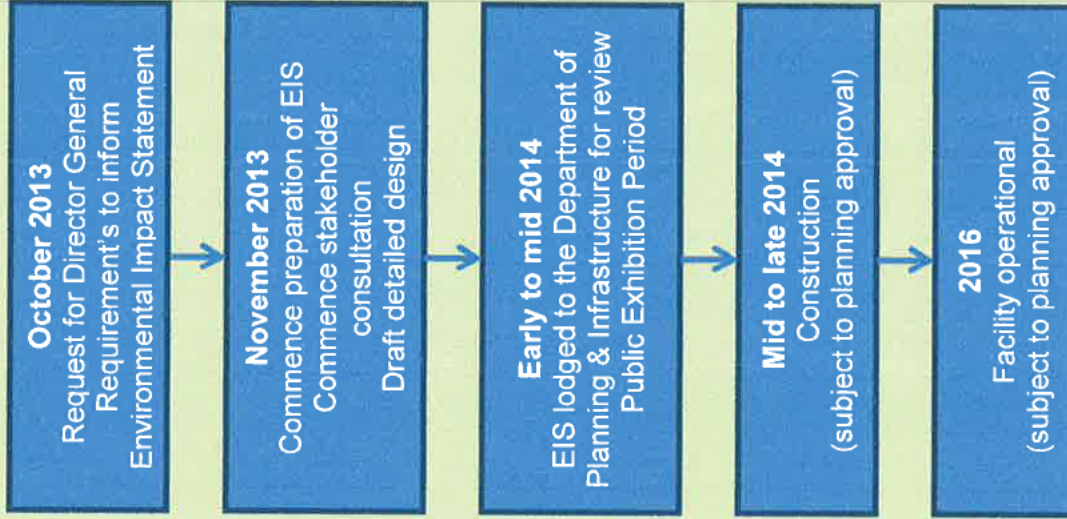

An average NSW home uses 7,300 kWh of electricity a year. This equates to 10 million tonnes of coal being burnt every year to cover the electricity needs of NSW households.

The greenhouse gases from coal burning power stations and other similar sources can be significantly reduced by the use of Waste from Energy power generation technologies which are currently in use in Europe and the United Kingdom.

These power stations are smaller and more efficient than the traditional ones. They do **not** have huge cooling towers or chimneys. They do not belch plumes into the air and generally are not even recognisable as power stations.

The Next Generation NSW (TNG) is a local company based here in NSW and we are proposing to develop just such an Electricity Generation Facility at Honeycomb Drive, Eastern Creek, located within the M7 Business Hub.



The proposed project would complement the existing waste disposal and recycling facility on the adjacent site on Honeycomb Drive, Eastern Creek.

Landfills generate greenhouse gases. The Genesis facility at Eastern Creek was estimated to generate 1.6 million tonnes of carbon dioxide (equivalent) per year.

Using waste from Genesis to power an electricity generation plant will divert about 1 million tonnes of waste away from landfill per year. This will hugely reduce the generation of greenhouse gases.

A plant of this kind would generate 140MW of "green" electricity which is enough energy to power over 200,000 homes.

The power generated would be fed back into the NSW grid and be used to power surrounding businesses. This in turn facilitates the development of new businesses and increases employment opportunities in western Sydney.

This project simultaneously helps us to solve the energy and waste needs of western Sydney over the next 30 years.

Thermal technology will convert waste that would otherwise go to landfill into green power.



It's Clean and It's Green

The proposed Facility will use safe, reliable and proven technology to create green energy from waste that would otherwise go straight to landfill.

Best practice accountable, real time emissions monitoring technology will be installed to constantly demonstrate that there are no harmful emissions to the environment, air, soil or water.

The project will create hundreds of jobs during the two year construction and commissioning phase, 65 new direct jobs when operational and an expected several thousand indirect jobs from the new businesses in the Business Hub.

The manufacturer of this particular type of plant has not had a breach of its operating standards.

Detailed technical investigations in connection with an Environmental Impact Statement are currently underway.

These will include a number of studies to assist in assessing the Facility. The technical studies will include air quality and odour; human health; noise management; traffic and transport; soil and water; greenhouse gas; riparian corridor; heritage; flora and fauna; hazards and fire risks; and visual amenity.

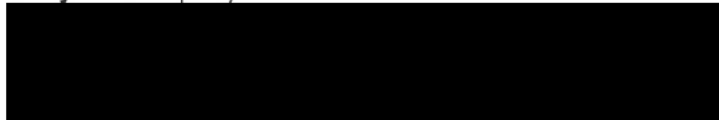

QUESTIONS RAISED BY KERRI BRADBURY IN A PHONE CONVERSATION (16/12/13)

Q. What is meant when Ian stated that the Energy From Waste (EFW) Facility will solve the future waste needs of Sydney?

A. Most landfills in Sydney are to be found in the western suburbs because that is where the last remaining open spaces are. No-one particularly wants more landfills and even Western Sydney will be running out of space. What Ian means is that the EFW Facility will assist in the future landfill demands for the Sydney metropolitan area and primarily Western Sydney. By diverting up to 1.0-1.2M tonnes of waste from landfill per annum to instead be used as fuel in electricity generation this should assist in alleviating the demand for additional landfill sites in metropolitan Sydney for decades.

Q. Concerned about the increase in transport of waste for the EFW Facility?

A. The Genesis site has approval for the delivery of waste by trucks for 2 million tonnes of waste per annum. Trucks are not allowed to access the site via residential areas and trucks can only enter the site via the industrial/ commercial area off wonderland drive and Honeycomb road.

Estimates were made at the time of the number of vehicles that would be visiting the Genesis facility and in reality so far Genesis has come in comfortably under the estimates. The EFW Facility proposal will have a provision to accommodate a slight increase in waste fuel to site but this will only equate to an increase of 1.5 trucks per hour and once again these trucks will not be on local residential roads.

Q. Concerned about the emissions and the chemical content of these emissions on the local community. What will be coming out of the stacks?

A. Several dozen of these EFW Facilities are in operation across Europe and the United Kingdom and have been for a number of years where they too have run out of landfill space and have also tried to cease dumping their waste in their oceans.

Because of the types of waste involved as fuel and because it is from the construction and demolition sector it is not of the toxic variety. Nevertheless when anything burns it gives of various types of exhausts. In these Energy plants there are scrubbers which deal with each of the exhaust gases in turn. Actually quite basic, easily obtainable chemicals such as Urea, Builders Lime and activated charcoal are used through various processes to manage and neutralise Nitrous oxides, acid gases and organic compounds or heavy metals. Though the plant is sophisticated in its processes the chemistry is not that complex.

There will be remote online 24 hour monitoring of the emissions by the Environmental Protection Authority (EPA) which will be able to immediately detect anything outside of the normal operating

parameters. This is quite unlike traditional coal fired power stations where the precise chemical composition of the coal is unknown and there are no protections against exhaust gases.

Q. As it is close to Christmas it would probably be better if you can organise a Community Open Day on a Saturday in early February 2014.

A. DW stated that it this can be organised at short notice if required. To be discussed with TNG.

Dear Mr Atalla,

We are presenting you with 42 signed letters from a survey conducted in Minchinbury in May/June 2017.

The letter states how or when they found out about the DA Energy from Waste Incinerator, that they object to the incinerator and ask the NSW Government to stop it now and not to let it be approved with strict conditions.

The majority (72.5% or 29 residents) did not know about the TNG Energy from Waste Incinerator until just in the last 6 months. This was mainly from Facebook, Community Flyers, News on TV, word of mouth from neighbours, parents at school and a Council forum. One resident mentioned that they received an envelope from TNG. There were three (3) residents who only found out about it on the day we spoke to them. This contributes to our concern that consultation was inadequate, since this has been going on since December 2013.

Could you please represent these residents in parliament? Thank you for your ongoing support.

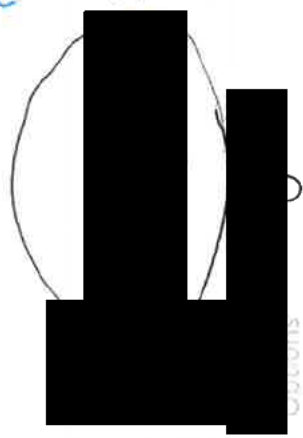

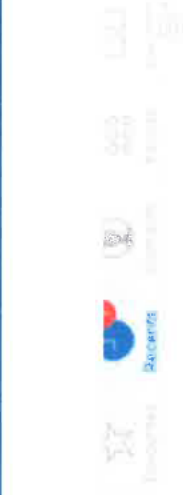

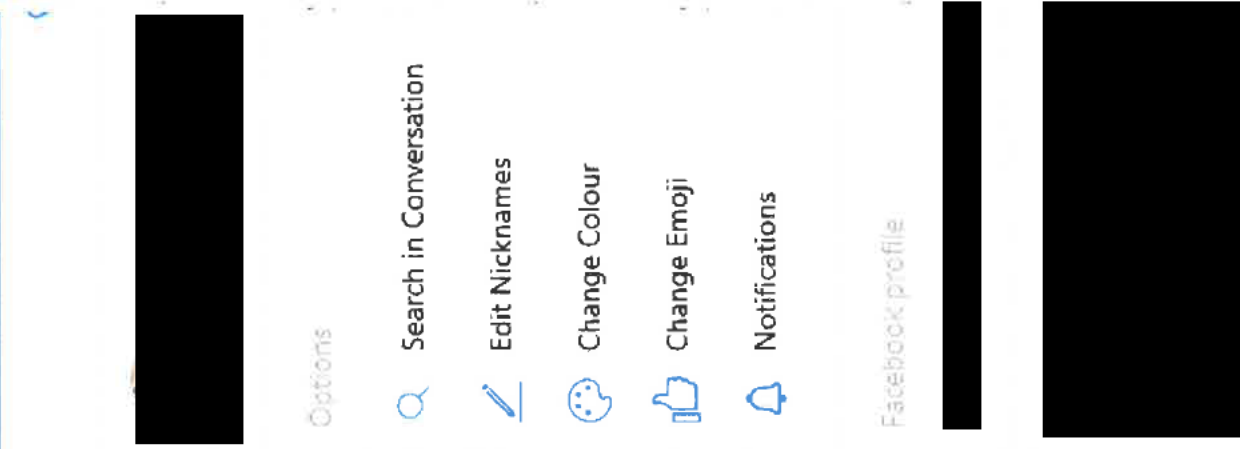
