



## Loreto Kirribilli IPC Briefing DoP Conditions for discussion

**B5 Building Design** - To maintain appropriate levels of privacy to the adjoining neighbours and enable view sharing, the Applicant must modify the design of the "learning hub" building, through the following:

- (a) Delete the raised roof garden;
- (b) Floor level of the roof must not exceed FFL 34.5;
- (c) Restrict any access to the roof above the learning hub except for maintenance and cleaning purposes only;
- (d) Remove the 1.5 m high glass balustrade and propose alternative balustrades;
- (e) Access for circulation or fire egress purposes is restricted to the area between Marian Centre and the lift /stairs at the southern end only; and
- (f) Remove any lift opening on the northern side.

**E17 Landscaping** - The roof above the learning hub must not include a roof garden.

**F8** - The roof top of the new learning hub in the western precinct is to be only used for maintenance and cleaning purposes and not for any other use.

**F9 Noise Control - Other Uses** - The roof area between the Marian Centre and the learning hub, up to the southern façade of the building is to be used for circulation between the two buildings (Marian Centre and learning hub) to avoid any adverse amenity impact on the surrounding residents.





Figure 36: View of the roof from Unit 9/111 Carabella Street (Source: Applicant's RtS)






