The NSW Department of Planning and Environment has now completed its evaluation of this development proposal and referred it to us – the Independent Planning Commission NSW – for determination.

Because there's been so much interest in this proposal, we're holding a public meeting to listen carefully to the community's views. This is your last chance to comment on the Department's assessment report before our independent experts make a final decision on the proposal.

The meeting will be held at Mantra On Salt Beach, The Pavilion Room, Gunnamatta Avenue Kingscliff NSW 2487, on Tuesday, 23 October 2018, at 9:00am.

If you wish to apply to speak at the public meeting, you must complete an expression of interest form and return it via email to <a href="mailto:ipcn@ipcn.nsw.gov.au">ipcn@ipcn.nsw.gov.au</a> so that it is received by no later than 5:00pm on Wednesday, 17 October 2018.

And if you can't make it or just don't like public speaking, that's not a problem! You can make a written comment up to one week after the meeting. Written comments are weighed the same as spoken presentations.
