Sunrise Mine Modification 4 (DA 374-11-00 MOD 4)

As discussed during the Department's meeting with the Independent Planning Commission on 11 October 2018, the following clarifications and corrections to the Secretary's Assessment Report for the Sunrise Mine Modification 4 application should be considered.

1. Page iv of the Executive Summary states "almost half (1,451 ML/year) of the project's overall water demand (3,135 ML/year) would be supplied by the water treatment plant."

The Department notes that 1,451 ML/year would be supplied by the water treatment plant. and an additional 3,135 ML/year would be required from external sources (the borefield and Lachlan River).

2. Tables 3 and 4 of the report include traffic numbers for the approved and modified project that reflect the latest information provided to the Department before a recommendation was made.

However, Clean TeQ has since provided updated traffic data for the modified project with the use of high capacity trucks and shuttle buses (see enclosed letter dated 12 October 2018). This shows that overall the modified project would generate 34% less traffic than the approved project, including 10% fewer heavy vehicles movements. The revised data is shown in the tables below:

3. Page 25 of the report incorrectly identifies changes to noise impacts at the "Moorelands" residence. These changes have also been included in the recommended amendments to the conditions.

The Department notes that there are no predicted changes to the noise limits at any properties around the limestone quarry. The correct noise criteria for the limestone quarry with the introduction of sleep disturbance limits is shown below:
