The Independent Planning Commission NSW is the consent authority for the Vickery Extension Project SSD 7480. The Minister for Planning has requested the Commission to conduct a public hearing into the carrying out of this Project.

The preliminary stage of this multi-stage public hearing was originally scheduled for December 2018 but had to be postponed due to unprecedented public interest.

It will now be held over two days at:
