Happy New Year.

Our response to your queries is below:

- 1. This matter has been discussed with the Department of Education. Education is currently considering options to secure a new school site. The timeframes for a site to be secured are unknown at this stage.
- 2. The provision of a school would only be one consideration in lifting the cap. The Department would need to consult with other infrastructure agencies such as Transport for NSW and Roads and Maritime Service to seek their feedback that there is sufficient infrastructure capacity to service the precinct. The cap could be lifted via a council or Department led planning proposal.
- 3. Land amalgamation, while noted, was not considered in detail in the rezoning of the precinct through the Planned Precinct process. The focus was on built form outcomes across the precinct, recognising that a number of sites that were being amalgamated through the process were by "option to purchase". However, based on the amalgamations that were occurring the Department was satisfied that council's request for the FSR bonus scheme to be based on a 10,000m2 site area could generally be met. Additionally, to recognise that sites could deliver additional public benefits the Department introduced clause 9.2 to The Hills LEP which allows floor area to be transferred to a development site should land be dedicated for a public purpose.
