Request for Gateway determination review – PP_2018_NORTH_001_00

I am writing to advise that the Department of Planning and Environment has received a Gateway determination review request for the above planning proposal. Details of the planning proposal are summarised below:

Proposal	The planning proposal seeks to amend the North Sydney Local Environmental Plan (LEP) 2013 in relation land at 41 McLaren Street, North Sydney to:
	 increase the maximum building height control from RL 100m AHD to RL 226m AHD; and
	 increase the minimum non-residential floor space ratio (FSR) from 0.5:1 to 3:1.
	The planning proposal seeks to enable a 45 storey mixed-use building that will include:
	 the refurbishment of a heritage-listed 8 storey commercial building; the addition of a residential tower comprising 37 storeys over the existing building, which has the capacity to accommodate approximately 224 units; and the construction of additional basement parking to accommodate a further 128 parking spaces to a total 219 spaces.

North Sydney Council has requested a review of the Gateway determination to challenge the basis of the Gateway determination. The Minister for Planning's delegate determined on 23 August 2018 that the proposal proceed subject to conditions.

The commission is requested to review the planning proposal and prepare advice concerning the merits of the review request. The advice should include a clear and concise recommendation to the Minister's delegate confirming whether, in its opinion, the planning proposal should proceed past Gateway.

The advice and recommendation should be provided within 28 days of receipt this letter and sent to the Department of Planning and Environment at GPO Box 39, Sydney NSW 2001.
