Specialising in urban design, urban housing and community buildings, Russell is a registered architect and urban designer with extensive experience in Australia and overseas. Russell has worked in Australia, France and New Zealand on major urban design and architectural projects. He has prepared the City of Sydney LEP and DCP 1996, two Plan reviews for the City of Adelaide Plan, projects for the National Capital Authority, Canberra and contributed to Sustainable Sydney 2030.

Russell was a member of the City of Sydney City Plan team which gained 2 national planning awards, the Royal Australian Planning Institute's Presidents Award and the National Planning Ministers Award.

As principal of OAA Russell has designed and built many urban apartment buildings and houses which are recognised for their design quality. Russell has lectured at three Sydney universities. He has appeared as an expert witness at the NSW Land and Environment Court on 20 occasions and the Queensland Planning and Environment Court on 5 occasions.

He was a panellist on SEPP 65 Design Review Panels for the Inner West Councils and Parramatta Council from the inception of SEPP 65 in 1999. Russell is currently a panellist on the City of Parramatta Design Excellence Advisory Panel and the Waverley Council Design Excellence Panel.

Russell has chaired the AIA NSW Chapter Design Competitions Committee. He has project managed and written the Brief for 7 International Design Competitions, and been a juror for 5 design competitions. Recent positions have been as Juror on City of Sydney and City of Parramatta Design Excellence Competitions and Competition Adviser for a Penrith City Council Design competition.
