## Request for Gateway determination review - PP\_2019\_KURIN\_001\_00

I am writing to advise the Independent Planning Commission that a Gateway determination review request has been submitted to the Department of Planning, Industry and Environment for the above planning proposal. Details of the planning proposal are summarised below:
