Thank you for providing the Department a copy of draft conditions.

The Department has reviewed the edits to the conditions and generally supports the additional condition and changes made.

The Department notes that there is a stray 'e' at the end of condition A5(a)

The Department also notes at the end of (b) in the new condition A7, we recommend that 'or' instead of 'and' be used, as compliance with each of the subclauses may not be achievable otherwise.

Alternatively it might be helpful if condition A7 specifically refer to occupation complying with Clause 18(1) of the SEPP rather than replicating clause 18(1) at condition A7, as this would allow IPC to rely on the interpretations in the SEPP.

Also, please note that an error has been found on the cover page that has been provided to IPC, which references 'Schedule 3' where there is none. Apologies for the error.
