Good afternoon Shaun,

Thank you for your time on the phone yesterday to discuss the revised PHA and accompanying letter regarding Modification 17 to the Shoalhaven Starches Expansion Project consent (MP06 0028-MOD-17).

It is understood that the letter prepared by Stephen Richardson of Cowman Stoddart Pty Ltd addresses inconsistencies within the PHA and supporting documentation that were identified by FRNSW following exhibition of the modification; specifically whether the proposal sought consent for additional bulk chemical storage, or relocation of existing storage. It is noted that the proposal is seeking approval for additional bulk chemical storage.

As discussed, FRNSW does not consider the proposed additional bulk chemical storage (caustic soda, hydrochloric acid, and cationic reagent) to present a fire risk given the chemicals are non-flammable and non-combustible, and subsequently do not affect the fire risk profile for the site. As such, FRNSW are satisfied that all agency submissions have been adequately addressed and offer no further comment.

# Notification of Modification Shoalhaven Starches Expansion Project (MOD 17)

Thank you for your submission of the Statement of Environmental Effects report (the Report, dated 13 December 2019) for the above development to Fire and Rescue NSW (FRNSW) for agency review and comment.

It is understood that the Report has been prepared by Cowman Stoddart Pty Ltd on behalf of Shoalhaven Starches Pty Ltd (the Applicant) to address proposed modifications to Project Approval MP06\_0228, including the; relocation of the baghouse for starch dryer no. 5, installation of a service lift adjacent to starch dryer no. 5, elevation of an approved service conduit aboveground to the packing plant, use of woodchips as part of the fuel source in boilers 2 and four 4, and modification of condition 14J(e) of the afore mentioned project approval. An addendum to the Report (the Addendum, dated 19 June 2020) detailing amendments to the modification has also been reviewed as part of this submission.

The following comments and recommendations are provided following a review of relevant parts of the Report and Addendum.

It is noted that the Preliminary Hazard Analysis (PHA) report (dated 18 June 2020) prepared by Pinnacle Risk Management Pty Ltd has been revised to assess the changes proposed in Modifications 16 and 17. Whilst the PHA concluded that the modifications presented no significant increase in the risk profile of the site, it is unclear if consideration was given to risks associated with the provisions for future bulk chemical storage noted in Section 2.3 Additional Bulk Chemical Storage of the Addendum. It is recommended that clarification be provided as to whether the Modifications are proposing additional bulk chemical storage, or relocation of the existing; caustic soda, hydrochloric acid, and cationic reagent storage.
