Hi Aditi,

Thank you for the opportunity to comment on the amended proposal for the proposed Westmead Catholic Community Education campus at 2 Darcy Road, Westmead. As discussed, we have no issues with the revised amendments of the proposal, noting the following:

- The proposed changes in the SSD relate to previous concerns in transport and traffic and quality of open space. The proponent has made minor amendments to the site access at Mother Teresa intersection and associated repositioning of the Parish Church. There are also minor amendments to the intersection of Darcy Road and access to the multi-storey car park

at Catherine McAuley and the removal of the school pick-up and drop off area.

- As an update on the draft Westmead Place Strategy, we have been working with TfNSW on the Strategic Transport Study as traffic management is one of the key concerns raised in the submissions during the exhibition of the Place Strategy. The transport study will identify key initiatives following a vision and validate approach and movement and place framework. We are anticipating that the strategic transport study will be completed in December and the findings will be incorporated into the final Place Strategy. We also note that the challenges in the Precinct is the significant reliance on car dependency and the shift towards public and active transport.
