#### **SCHEDULE 2**

## PART A ADMINISTRATIVE CONDITIONS

## **OBLIGATION TO MINIMISE HARM TO THE ENVIRONMENT**

A1. In addition to meeting the specific performance measures and criteria in this consent, all reasonable and feasible measures must be implemented to prevent, and if prevention is not reasonable and feasible, minimise, any material harm to the environment that may result from the construction and operation of the development, and any rehabilitation required under this consent.

#### **TERMS OF CONSENT**

- A2. The development may only be carried out:
  - (a) in compliance with the conditions of this consent;
  - (b) in accordance with all written directions of the Planning Secretary; and
  - (c) generally in accordance with the EIS and Development Layout.
- A3. Consistent with the requirements in this consent, the Planning Secretary may make written directions to the Applicant in relation to:
  - (a) the content of any strategy, study, system, plan, program, review, audit, notification, report or correspondence submitted under or otherwise made in relation to this consent, including those that are required to be, and have been, approved by the Planning Secretary; and
  - (b) the implementation of any actions or measures contained in any such document referred to in condition A3(a).
- A4. The conditions of this consent and directions of the Planning Secretary prevail to the extent of any inconsistency, ambiguity or conflict between them and a document/s listed in condition A2(c). In the event of an inconsistency, ambiguity or conflict between any of the document/s listed in condition A2(c), the most recent document prevails to the extent of the inconsistency, ambiguity or conflict.

#### LIMITS OF CONSENT

## Identification of Approved Extraction Area

- A5. At least one month before the commencement of construction:
  - (a) a registered surveyor must be engaged to mark out the boundaries of the approved areas of extraction within the site (as set out in Appendix 2); and
  - (b) the Planning Secretary must be provided with a survey plan of such boundaries and their GPS coordinates.
- A6. The boundaries of the approved areas of extraction within the site must be clearly marked in a manner that allows them to be easily identified at all times during the carrying out of quarrying operations.

#### **Quarrying Operations**

- A7. Quarrying operations may be carried out on the site for a period of 30 years from the date of the commencement of the development.
  - **Note:** Under this consent, the Applicant is required to decommission and rehabilitate the site and carry out other requirements in relation to quarrying operations. Consequently, this consent will continue to apply in all respects other than to permit the carrying out of quarrying operations until the rehabilitation of the site and other requirements have been carried out to the required standard.
- A8. The Applicant must not extract more than 600,000 tonnes of hard rock quarry products at the site in each calendar year.

#### **Transport Operations**

- A9. The Applicant must limit total truck movements at the site (i.e. arrivals and dispatches) to a maximum of:
  - (a) 170 truck movements per day; and
  - (b) 20 truck movements per hour.
  - Note: Truck movements to and from the site are also controlled by the operating hours specified in condition <u>A11.A12.</u>

#### A10. The Applicant must:

- (a) ensure that all trucks travelling southbound from the quarry first\_turn left (i.e. northbound) from Italia Road onto the Pacific Highway and utilise the Taren Road Interchange to perform a U-turn and do not turn right (i.e. southbound) from Italia Road onto the Pacific Highway; and
- (b) ensure at the intersection of Italia Road and the new right of carriageway that:
  - (i) no trucks turn left from the right of carriageway onto Italia Road; and
  - (ii) no trucks turn right from Italia Road onto the right of carriageway.

## Hours of Operation

A10.<u>A11.</u> The Applicant must comply with the operating hours set out in Table 1.

A11.A12. The following activities may be carried out outside the hours and restrictions specified in Table 1:

- (a) delivery or dispatch of materials as requested by Police or other public authorities; and
- (b) emergency work to avoid the loss of lives, property or to prevent environmental harm.

In such circumstances, the Applicant must notify the Department and affected residents prior to undertaking the activities, or as soon as is practical thereafter.

#### NOTIFICATION OF COMMENCEMENT

A12.A13. The date of commencement of each of the following phases of the development must be notified to the Department in writing, at least one month before that date:

- (a) commencement of construction under this consent;
- (b) commencement of quarrying operations;
- (c) cessation of quarrying operations; and
- (d) any period of suspension of quarrying operations.

## CONTRIBUTIONS TO COUNCIL

- A13.A14. The Applicant must make annual financial contributions to Council towards the maintenance of roads used for haulage of quarry products, where Council is the roads authority under the *Roads Act 1993*. The contributions must be determined in accordance with the Port Stephens Local Infrastructure Contributions Plan 2020 (including any updated or revised version of this plan) for local roads within the local government area.
- A14.<u>A15.</u> If there is a dispute over the determination of the contributions in condition A14, the Applicant or Council may refer the matter to the Planning Secretary for resolution. The decision of the Planning Secretary will be final.

#### COMMUNITY CONSULTATIVE COMMITTEE

A15.<u>A16.</u> Within 6 months from the date of commencement of development, a CCC must be established for the development in accordance with the Department's Community *Consultative Committee Guidelines: State Significant Projects* (2023).

## EVIDENCE OF CONSULTATION

A16.A17. Where conditions of this consent require consultation with an identified party, the Applicant must:

- (a) consult with the relevant party prior to submitting the subject document; and
- (b) provide details of the consultation undertaken including:
  - (i) the outcome of that consultation, matters resolved and unresolved; and
  - (ii) details of any disagreement remaining between the party consulted and the Applicant and how the Applicant has addressed the matters not resolved.

## STAGING, COMBINING AND UPDATING STRATEGIES, PLANS OR PROGRAMS

A17.A18. With the approval of the Planning Secretary, the Applicant may:

- (a) prepare and submit any strategy, plan or program required by this consent on a staged basis (if a clear description is provided as to the specific stage and scope of the development to which the strategy, plan or program applies, the relationship of the stage to any future stages and the trigger for updating the strategy, plan or program);
- (b) combine any strategy, plan or program required by this consent (if a clear relationship is demonstrated between the strategies, plans or programs that are proposed to be combined); and
- (c) update any strategy, plan or program required by this consent (to ensure the strategies, plans and programs required under this consent are updated on a regular basis and incorporate additional measures or amendments to improve the environmental performance of the development).
- A18.A19. If the Planning Secretary agrees, a strategy, plan or program may be staged or updated without consultation being undertaken with all parties required to be consulted in the relevant condition in this consent.

## PROTECTION OF PUBLIC INFRASTRUCTURE

A19.A20. Unless the Applicant and the applicable authority agree otherwise, the Applicant must:

- (a) repair, or pay the full costs associated with repairing, any public infrastructure that is damaged by carrying out the development; and
- (b) relocate, or pay the full costs associated with relocating, any public infrastructure that needs to be relocated as a result of the development.
- **Note:** This condition does not apply to any damage to roads or public infrastructure caused as a result of general road usage or otherwise addressed by contributions required by condition A14 of this consent.

#### DEMOLITION

A20.<u>A21.</u> All demolition must be carried out in accordance with Australian Standard AS 2601-2001 The Demolition of Structures (Standards Australia, 2001).

#### STRUCTURAL ADEQUACY

A21.<u>A22.</u> All new buildings and structures, and any alterations or additions to existing buildings and structures, that are part of the development, must be constructed in accordance with the relevant requirements of the BCA.

#### Notes:

- Under Part 6 of the EP&A Act, the Applicant is required to obtain construction and occupation certificates for the proposed building works.
- Part 8 of the EP&A Regulation sets out the requirements for the certification of the development.

#### **OPERATION OF PLANT AND EQUIPMENT**

A22.A23. All plant and equipment used on site, or to monitor the performance of the development, must be:

- (a) maintained in a proper and efficient condition; and
- (b) operated in a proper and efficient manner.

#### COMPLIANCE

A23.A24. The Applicant must ensure that all of its employees, contractors (and their sub-contractors) are made aware of, and are instructed to comply with, the conditions of this consent relevant to activities they carry out in respect of the development.

## **APPLICABILITY OF GUIDELINES**

- A24.<u>A25.</u> References in the conditions of this consent to any guideline, protocol, Australian Standard or policy are to such guidelines, protocols, Standards or policies in the form they are in as at the date of this consent.
- A25.A26. However, consistent with the conditions of this consent and without altering any limits or criteria in this consent, the Planning Secretary may, when issuing directions under this consent in respect of ongoing monitoring and management obligations, require compliance with an updated or revised version of such a guideline, protocol, Standard or policy, or a replacement of them.

## **PRODUCTION DATA**

A26.<u>A27.</u> Each year, from the commencement of quarrying operations, the Applicant must provide calendar year quarry production data in the Annual Review (required under condition D9).

## PART B SPECIFIC ENVIRONMENTAL CONDITIONS

## NOISE

## **Operational Noise Criteria**

B1. The Applicant must ensure that the noise generated by the development does not exceed the criteria in <u>Table 2</u>-Table 2 at any residence on privately-owned land.

- B2. Noise generated by the development must be measured in accordance with the relevant requirements and exemptions (including certain meteorological conditions) of the *NSW Noise Policy for Industry* (EPA, 2017). Appendix 4 sets out the meteorological conditions under which these criteria apply and the requirements for evaluating compliance with these criteria.
- B3. The noise criteria in <u>Table 2Table 2</u> do not apply if the Applicant has an agreement with the owner/s of the relevant residence or land to exceed the noise criteria, and the Applicant has advised the Department in writing of the terms of this agreement.

## Noise Operating Conditions

- B4. The Applicant must:
  - (a) take all reasonable steps to minimise all noise from construction, operational and road transport activities, including low frequency noise and other audible characteristics;
  - (b) maintain the existing ridgeline along the southern boundary of the site as an acoustic barrier to the quarrying operations to a height of no less than relative level 57.5 m until the final year of quarrying operations;
  - (c) conduct noise monitoring and assessment prior to removal of the ridgeline in the final year of quarrying operations, to determine the appropriate temporary noise barrier location and design to ensure noise criteria in Condition B1 are met;
  - (d) operate a comprehensive noise management system commensurate with the risk of impact to ensure compliance with the relevant conditions of this consent;
  - (e) take all reasonable steps to minimise the noise impacts of the development during noise-enhancing meteorological conditions;
  - (f) engage a suitably qualified and experienced person(s) to carry out regular attended noise monitoring (at least quarterly, unless otherwise agreed with the Planning Secretary) to determine whether the development is complying with the relevant conditions of this consent (including, but not limited to at Lot 6 DP247953 (currently known as Eagleton Ridge Disability Services) unless otherwise agreed by the landowner);
  - (g) regularly assess the noise monitoring data and modify or stop operations on the site to ensure compliance with the relevant conditions of this consent; and
  - (h) develop and implement a protocol for identifying any noise-related exceedance, incident or non-compliance and for notifying the Department and relevant stakeholders of these events.
- B5.
   Prior to the commencement of quarrying operations, the Applicant must offer, and implement if accepted by the landowner, the following to the landowner of Lot 6 DP247953 (currently known as Eagleton Ridge Disability Services):

   (a)
   covering of the costs to take the residents of the property off site (e.g., on a day trip) during all blasts for the first 12 months of blasting; and
  - (b) have a suitably qualified and experienced person(s) at this property conducting noise and vibration monitoring during all blast for the first 12 months of blasting.

## BLASTING

## **Blasting Criteria**

B5.B6. The Applicant must ensure that blasting on the site does not cause exceedances of the criteria in Table 3 Table 3.

B6.B7. The blasting criteria in <u>Table 3</u> do not apply if the Applicant has an agreement with the owner/s of the relevant residence to exceed the blasting criteria, and the Applicant has advised the Department in writing of the terms of this agreement.

#### **Blasting Frequency**

- B7.B8. The Applicant may carry out a maximum of 2 blasts per day (not more than 4 per week) during construction and a maximum of 1 blast per day during quarrying operations.
- B8.B9. Condition B8 does not apply to blasts that generate ground vibration of 0.5 mm/s or less at any residence on privatelyowned land, or to blast misfires or to blasts required to ensure the safety of the mine, its workers or the general public.

#### Notes:

- For the purposes of this condition, a blast refers to a single blast event, which may involve a number of individual blasts fired in quick succession in a discrete area of the quarry.
- For the avoidance of doubt, should an additional blast be required after a blast misfire, this additional blast and the blast misfire are counted as a single blast.

#### **Property Inspections**

- B9.B10. Prior to the commencement of quarrying operations, If the Applicant must offer toreceives a written request from the owner of any privately-owned land within 1 kilometre of any approved extraction area on the site, for a property inspection to establish the baseline condition of any buildings and structures on their land, or to have a previous property inspection updated, then within 2 months of receiving any property owner accepting this request offer the Applicant must:
  - (a) commission a suitably qualified, experienced and independent person, whose appointment is acceptable to both parties to:
    - (i) establish the baseline condition of any buildings and other structures on the land, or update the previous property inspection report; and
    - (ii) identify measures that should be implemented to minimise the potential blasting impacts of the development on these buildings and structures; and
  - (b) give the landowner a copy of the new or updated property inspection report.
- B10.B11. If there is a dispute over the selection of the suitably qualified, experienced and independent person, or the Applicant or the landowner disagrees with the findings of the property inspection report, either party may refer the matter to the Planning Secretary for resolution.

#### **Property Investigations**

- B11.B12. If the owner of any privately-owned land within 2 kilometres of any approved extraction area on the site or any other landowner where the Planning Secretary is satisfied an investigation is warranted, claims in writing that buildings or structures on their land have been damaged as a result of blasting on the site, then within 2 months of receiving this written claim the Applicant must:
  - (a) commission a suitably qualified, experienced and independent person, whose appointment is acceptable to both parties to investigate the claim; and
  - (b) give the landowner a copy of the property investigation report.
- B12.B13. If this independent property investigation confirms the landowner's claim, and both parties agree with these findings, then the Applicant must repair the damage to the satisfaction of the Planning Secretary.
- B13.B14. If there is a dispute over the selection of the suitably qualified, experienced and independent person, or the Applicant or the landowner disagrees with the findings of the independent property investigation, then either party may refer the matter to the Planning Secretary for resolution.

#### **Blast Operating Conditions**

(a)

B14.B15. During blasting operations, the Applicant must:

- take all reasonable steps to:
  - (i) ensure the safety of people and livestock from blasting impacts of the development;

- (ii) protect public or private infrastructure and property in the vicinity of the site from blasting damage associated with the development; and
- (iii) minimise blast-related dust and fume emissions;
- (b) operate a suitable system to enable members of the public to get up-to-date information on the proposed blasting schedule on the site and implement a protocol for investigating and responding to blast-related complaints;
- (c) identify any blast-related exceedance, incident or non-compliance and notify the Department and relevant stakeholders of these events; and
- (d) carry out regular blast monitoring to determine whether the development is complying with the relevant conditions of this consent.

## AIR QUALITY

## Odour

B15.B16. The Applicant must ensure that no offensive odours are emitted from the site, as defined under the POEO Act.

## Air Quality Criteria

B16.B17. The Applicant must ensure that particulate matter emissions generated by the development do not cause exceedances of the criteria in Table 4Table 4 at any residence on privately-owned land.

B17.B18. The air quality criteria in Table 4 Table 4 do not apply if the Applicant has an agreement with the owner/s of the relevant residence or infrastructure to exceed the air quality criteria, and the Applicant has advised the Department in writing of the terms of this agreement.

## Air Quality and Greenhouse Gas Operating Conditions

#### B18.B19. The Applicant must:

- (a) take all reasonable steps to:
  - (i) minimise odour, fume, and dust (including PM<sub>10</sub> and PM<sub>2.5</sub>) emissions of the development;
  - (ii) minimise any visible off-site air pollution generated by the development;
  - (iii) minimise the extent of potential dust generating surfaces exposed on the site at any given point in time; and
  - (iv) improve energy efficiency and minimise Scope 1 and Scope 2 greenhouse gas emissions generated by the development;
- (b) operate a comprehensive air quality management system that uses a combination of meteorological forecasting and real-time air quality monitoring data to guide the day-to-day planning of quarrying operations and the implementation of both proactive and reactive air quality mitigation measures to ensure compliance with the relevant conditions of this consent;
- (c) minimise the air quality impacts of the development during adverse meteorological conditions and extraordinary events (see Note c to <u>Table 4Table 4</u> above);
- (d) engage a suitably qualified and experienced person(s) to carry out routine air quality monitoring in accordance with the *Approved Methods for Sampling and Analysis of Air Pollutants in New South Wales* (EPA, 2022), to determine whether the development is complying with the relevant conditions in this consent; and

- (e) regularly assess meteorological and air quality monitoring data and relocate, modify or stop operations on the site to ensure compliance with the relevant conditions of this consent; and
- (f) develop and implement a protocol for identifying any air quality-related exceedance, incident or noncompliance and for notifying the Department and relevant stakeholders of these events.

#### Quarry-owned Land

B19.B20. The Applicant must ensure that all reasonable and feasible avoidance and mitigation measures are employed so that particulate matter emissions generated by the development do not cause exceedances of the criteria in <u>Table 4</u> at any occupied residence on quarry-owned land unless:

- (a) the tenant has been notified of any health risks associated with such exceedances in accordance with the notification requirements under Part C of this consent; and
- (b) the tenant of any land owned by the Applicant can terminate their tenancy agreement without penalty at any time, subject to giving reasonable notice,

to the satisfaction of the Planning Secretary.

#### METEOROLOGICAL MONITORING

B20.B21. Prior to the commencement of construction and for the life of the development, the Applicant must ensure that there is a suitable meteorological station operating in close proximity to the site that:

- (a) complies with the requirements in the Approved Methods for Sampling and Analysis of Air Pollutants in New South Wales (EPA, 2022); and
- (b) is capable of measuring meteorological conditions in accordance with the *NSW Noise Policy for Industry* (EPA, 2017),

unless a suitable alternative is approved by the Planning Secretary following consultation with the EPA.

#### SOIL AND WATER

## Water Supply

- B21.B22. The Applicant must ensure that it has sufficient water for all stages of the development, and if necessary, adjust the scale of the development, within the limits of consent set out in Part A of Schedule 2, to match its available water supply.
- B22.B23. The Applicant must report on water take from the site each year (direct and indirect) in the Annual Review, including harvestable rights and water taken under each water licence.
  - Note: Under the Water Act 1912 and/or the Water Management Act 2000, the Applicant is required to obtain all necessary water licences for the development.

#### Compensatory Water Supply

- B23.B24. The Applicant must provide a compensatory water supply to any landowner of privately-owned land whose rightful water supply is adversely and directly impacted (other than an impact that is minor or negligible) as a result of the development, in consultation with NSW DCCEEW Water Group, and to the satisfaction of the Planning Secretary.
- B24.B25. The compensatory water supply measures must provide an alternative long-term supply of water that is equivalent, in quality and volume, to the loss attributable to the development. Equivalent water supply should be provided (at least on an interim basis) as soon as practicable after the loss is identified, unless otherwise agreed with the landowner.
- B25.B26. If the Applicant and the landowner cannot agree on whether the loss of water is to be attributed to the development or the measures to be implemented, or there is a dispute about the implementation of these measures, then either party may refer the matter to the Planning Secretary for resolution.
- B26.B27. If the Applicant is unable to provide an alternative long-term supply of water, then the Applicant must provide compensation, to the satisfaction of the Planning Secretary.
  - **Note:** The Water Management Plan (see condition\_-B30B35) is required to include trigger levels for investigating potentially adverse impacts on water supplies.

#### Water Discharges

B27.B28. The Applicant must ensure that all surface water discharges from the site comply with all relevant provisions of the POEO Act, including any discharge limits (both volume and quality) set for the development in any EPL.

## Water Management System

B28.B29. The Applicant must ensure that the on-site water management system is designed and constructed:

(a) to prevent discharges during rainfall events up to the one in 500 year ARI 24 hour storm event; and

(b) in accordance with Managing Urban Stormwater Volume 1 (Landcom 2004) and Managing Urban Stormwater: Soils and Construction Volume 2E, Mines and Quarries (DECC 2008).

## Water Management Plan

B29.B30. The Applicant must prepare a Water Management Plan for the development. This plan must:

- (a) be prepared by suitably qualified and experienced person/s whose appointment has been endorsed by the Planning Secretary;
- (b) be prepared in consultation with EPA, NSW DCCEEW Water Group and Hunter Water; and
- (c) include a: (i) Sit
  - Site Water Balance that:
    - includes details of:
      - sources and security of water supply;
      - water use and management on the site;
      - off-site discharges and water transfers;
      - metering of water volumes in all water storages and volumes of water pumped between water storages and discharged off-site;
      - reporting procedures, including the annual preparation of a site water balance; and
    - minimises clean and potable water use on the site;
  - (ii) Surface Water Management Plan, that includes:
    - detailed baseline data on surface water flows, water quality, riparian condition and geomorphic stability in watercourses and/or water bodies that could potentially be affected by the development including Seven Mile Creek and Grahamstown Dam;
    - detailed information on predicted off-site discharges, including:
      - once constructed, baseline data on water quality in water storages on the site, including the inpit sump(s) and treatment dams;
      - predicted controlled and uncontrolled off-site discharge volumes, frequencies and rates;
      - dirty water treatment options to ensure compliance with condition\_B35-B33, including gross pollutant traps, floating wetlands, bio-retention swales and flocculation systems;
      - measures to avoid, minimise or mitigate adverse water quality and geomorphological impacts of receiving waters from controlled and uncontrolled off-site discharges;
    - surface water impact assessment criteria, including trigger levels for investigating any potentially adverse impacts, and surface water management performance measures;
    - a detailed description of the surface water management system on the site, including the:
      - clean water diversion system;
      - erosion and sediment controls;
      - water storages;
      - dirty water management system; and
      - maintenance program to ensure adequacy capacity to capture and store runoff from the design rainfall criteria;
    - a program to monitor and report on:
      - any controlled and uncontrolled surface water discharges;
      - stream stability, riparian condition and geomorphic processes in receiving watercourses;
      - the effectiveness of the water management system, including regular independent reviews of the adequacy of the system;
      - surface water flows and quality in watercourses and/or waterbodies that could potentially be impacted by the development, including Seven Mile Creek and Grahamstown Dam;
    - a protocol for identifying and investigating any exceedances of the surface water impact assessment criteria and for notifying the Department, Hunter Water and other relevant stakeholders of these events.
    - (iii) Groundwater Management Plan that includes:
      - detailed baseline data of localised groundwater levels, yield and quality for groundwater resources potentially impacted by the development, including:
        - the existing groundwater bores;
        - groundwater supply for other water users; and

- groundwater dependent ecosystems identified in the vicinity of the site;
- a detailed description of the groundwater management system;
- groundwater performance criteria, including trigger levels for investigating any potentially adverse groundwater impacts;
- a groundwater bore replacement strategy for existing bores removed during quarrying activities;
- a program to periodically validate the groundwater model for the development in accordance with best practice methods, including an update of the model after the first 5 years of quarrying operations, and at least annual comparison of monitoring results with modelled predictions;
- a program to monitor and report on:
  - groundwater levels, yield and quality of groundwater resources potentially impacted by the development;
  - groundwater inflows into the extraction area;
  - seepage/leachate into the surrounding groundwater system;
  - impacts of the development on groundwater dependent ecosystems; and
  - impacts of the development on groundwater supply for other water users;
- a protocol for identifying and investigating any exceedances of the groundwater performance criteria and for notifying the Department and relevant stakeholders of these events; and
- a protocol to obtain appropriate water licence(s) to cover the volume of any unforeseen groundwater inflows into the extraction areas.

B30.B31. The Applicant must not commence construction of the access road or quarrying operations until the Water Management Plan is approved by the Planning Secretary.

B31.B32. The Applicant must implement the approved Water Management Plan.

## TRANSPORT

## Monitoring of Product Transport

B32.B33. The Applicant must keep accurate records of all laden truck movements to and from the site (including hourly truck movements) and publish a summary of these records on its website <u>at least</u> every 6 months.

## Transport Route

B33.B34. Prior to the commencement of construction, the Applicant must obtain development consent for the upgrade of the intersection at the junction of the Pacific Highway and Italia Road required by condition B35(a).

B34.B35. Prior to transporting any quarry products from the site on public roads, the Applicant must:

- (a) ensure <u>that</u> the intersection at the junction of The Pacific Highway and Italia Road is upgraded to the satisfaction of TfNSW;
- (b) ensure <u>that</u> the new right-of-carriageway across Lot 1 DP245116 and Lot 2 DP1158962 between Italia Road and Barleigh Ranch Way, <u>and the part of Barleigh Ranch Way between the new right of carriageway and the</u> <u>old right of carriageway, are is</u> constructed in accordance with Council Development Application 16-2021-160-1 to the satisfaction of Council;
- (c) upgrade and extend Barleigh Ranch Way between the junction of the <u>new-old</u> right-of carriageway and the quarry site access point in accordance with the EIS and the latest Austroads standards to the satisfaction of Council; and
- (d) design and construct the site access haul road bridge crossing over Seven Mile Creek in consultation with DPI Fisheries and in accordance with:
  - (i) the guidance series for "Controlled Activities- Guidelines for Watercourse Crossings on Waterfront Land" (DPI Water 2012);
  - (ii) "Why do Fish Need to Cross the Road? Fish Passage Requirements for Waterway Crossings" (DPI Fisheries 2003); and
  - (iii) "Policy and Guidelines for Fish Habitat Conservation and Management" (DPI Fisheries 2013).

## **Transport Operating Conditions**

B35.B36. The Applicant must:

- (a) ensure that all laden trucks entering or exiting the site have their loads covered; and
- (b) take all reasonable steps to minimise traffic safety issues and disruption to local road users.

## Traffic Management Plan

B36.B37. The Applicant must prepare a Traffic Management Plan for the development. This plan must:

- (a) be prepared by suitably qualified and experienced person/s;
- (b) be prepared in consultation with TfNSW and Council;
- (c) include details of:
  - (i) construction related traffic management measures;
  - (ii) all transport routes and traffic types to be used for development-related traffic, including identification of bridge load restrictions;
  - (iii) processes in place for the control of truck movements entering and exiting the site;
  - (iv) measures to be implemented to:
    - ensure compliance with the traffic operating conditions and other traffic related conditions of this consent, including but not limited to:
      - installation of any necessary road signage at intersections; and
      - implementation of any regulation and/or tracking measures;
    - manage the traffic impacts from contractors and subcontractors;
    - minimise traffic safety issues and disruption to local road users, including minimising potential for conflict with school bus operations;
    - minimise the transmission of dust and tracking of material onto the surface of public roads from vehicles exiting the site;
    - warn users of the possibility of encountering koalas;
    - monitor driver behaviour; and
    - participate in transport management investigations initiated by Council;
- (d) include a Drivers' Code of Conduct that includes procedures to ensure that drivers:
  - (i) adhere to posted speed limits or other required travelling speeds;
  - (ii) adhere to designated transport routes and travel times; and
  - (iii) implement safe and quiet driving practices, including restriction on the use of compression braking;
- (e) describe the measures to be put in place to ensure compliance with the Drivers' Code of Conduct.

B37.B38. The Applicant must not commence construction or quarrying operations until the Traffic Management Plan is approved by the Planning Secretary.

B38.B39. The Applicant must implement the approved Traffic Management Plan.

#### HERITAGE

## **Protection of Aboriginal Heritage**

- B39.B40. The Applicant must ensure that the development does not cause any direct or indirect impact on any identified Aboriginal object or Aboriginal place located outside the approved disturbance areas, beyond those predicted in the document/s listed in condition A2(c).
- B40.B41. If suspected human remains are discovered on the site, then all work surrounding the area must cease, and the area must be secured. The Applicant must immediately notify NSW Police Force and Heritage NSW, and work must not recommence in the area until authorised by NSW Police Force and Heritage NSW.

B41.B42. The Applicant must:

- (a) ensure that all known Aboriginal objects or Aboriginal places on the site are properly recorded, those records are kept up to date and are reported to the Aboriginal Heritage Information Management System.
- (b) ensure all workers receive suitable Aboriginal cultural heritage training/inductions prior to carrying out any activities which may cause impacts to Aboriginal objects or Aboriginal places, and that suitable records are kept of these inductions;
- (c) protect, monitor and manage identified Aboriginal objects and Aboriginal places within the approved disturbance areas in accordance with the commitments made in the document/s listed in condition A2(c); and
- (d) facilitate ongoing consultation and involvement of Registered Aboriginal Parties in the conservation and management of Aboriginal cultural heritage on the site.

## **BIODIVERSITY AND REHABILITATION**

#### **Biodiversity Offset Strategy**

B42.B43. The Applicant must retire the biodiversity credits specified in <u>Table 5</u> prior to commencing vegetation clearing.

The retirement of credits must be carried out in consultation with BCSD and in accordance with the Biodiversity Offset Scheme of the BC Act<sup>1</sup>.

<sup>1</sup> The available credit retirement options for the development include purchase and retirement of open market available biodiversity credits, payment into the Biodiversity Conservation Fund or establishment of a Biodiversity Stewardship Site(s). Credits retired for impacts on EPBC Act listed species and associated habitat must be like-for-like.

**Note**: The credits in <u>Table 5Table 5</u> were calculated in accordance with the BioBanking Assessment Methodology set out in the Framework for Biodiversity Assessment (Office of Environment and Heritage, 2014), and may need to be converted to reasonably equivalent 'biodiversity credits', within the meaning of the BC Act, to facilitate retirement. With the approval of the Planning Secretary and in consultation with BCS, the retirement of credits can be staged to align with progressive vegetation clearing.

B43.B44. The Applicant must ensure that:

- (a) riparian corridors are maintained on either side of watercourses outside of the direct disturbance footprint in accordance with the *Guidelines for controlled Activities on Waterfront Land* (DPI Water 2012); and
- (b) a Koala underpass is incorporated in the design and construction of the quarry access road bridge crossing over Seven Mile Creek.

#### **Biodiversity Stewardship Site**

B44.B45. The Applicant must retire at least part of the biodiversity credits specified in <u>Table 5Table 5</u> via the establishment of a Biodiversity Stewardship Site covering an area of 60.83 hectares of land within its land holding adjoining the southern and eastern portions of the site.

Note: To identify the general location of the Biodiversity Stewardship Site, refer to the plan in Appendix 45.

B45.B46. The Applicant must make suitable arrangements to provide long-term security and management funding for the Biodiversity Stewardship Site identified in condition B45 B49 in accordance with the Biodiversity Offset Scheme of the BC Act, to the satisfaction of the Planning Secretary and BCS.

#### **Biodiversity Management Plan**

B46.B47. The Applicant must prepare a Biodiversity Management Plan for the development. This plan must:

- (a) be prepared by suitably qualified and experienced person/s;
- (b) be prepared in consultation with BCS and Council;
- (c) describe the short, medium, and long-term measures to be undertaken to:
  - (i) implement the Biodiversity Offset Strategy; and
  - (ii) manage the remnant vegetation and fauna habitat on the site;
- (d) include a detailed description of the measures to be implemented on the site to:
  - (i) enhance the quality of existing vegetation, vegetation connectivity and fauna habitat, including through the assisted regeneration and/or targeted revegetation of appropriate canopy, sub-canopy, understorey and ground strata;
  - (i) ensure the Koala underpass required by condition B44(b) is designed in accordance with relevant policies and guidelines and in consultation with a koala expert;
  - (ii)(iii) maximise the salvage of resources within the approved disturbance area, including tree hollows, vegetative and soil resources, for beneficial reuse on site, including fauna habitat enhancement;
  - (iii)(iv) minimise impacts on tree hollows where reasonable and feasible;
  - (iv)(v) minimise impacts on fauna, including undertaking pre-clearance surveys;
  - (v)(vi) manage potential indirect impacts on threatened plant and animal species;
  - (vi)(vii) introduce naturally scarce fauna habitat features such as den structures, nest boxes and salvaged tree hollows, and promote the use of these introduced habitat features by threatened fauna species;

- (vii)(viii) monitor and protect vegetation and fauna habitat outside the approved disturbance area, including within riparian corridors and downstream aquatic environments;
- (viii)(ix) establish and/or retain vegetation screening to minimise the visual impacts of the development on surrounding receivers;
- (ix)(x) control weeds and feral pests, with consideration of actions identified in relevant threat abatement plans;

(x)(xi) manage the collection and propagation of seed;

(xi)(xii) control unrestricted access; and

(xiii)(xiii) manage bushfire hazards;

- (e) include a seasonally-based program to monitor and report on the effectiveness of biodiversity measures, and any progressive improvements that could be implemented to improve biodiversity outcomes;
- (f) include an adaptive management plan for groundwater dependent ecosystems that:
  - (i) is based on a Before After Control Impact (BACI) design to determine baseline conditions and identify any quarrying-related impacts in the vicinity of the site;
  - (ii) provides details of the baseline plot data for groundwater dependent ecosystems, including vegetation composition, structure and health, and any candidate threatened species associated with the community;
  - (iii) provides for the collection of groundwater level monitoring data (monthly) to detect any shallow groundwater drawdown during quarrying operations;
  - (iv) provides details of the offsetting regime that would be implemented in accordance with the Biodiversity Offsets Scheme of the BC Act if a change (partial or full direct impacts) in vegetation is detected and found to be caused by groundwater drawdown associated with the development; and
- (g) include details of who would be responsible for monitoring, reviewing, and implementing the plan.

B47.B48. The Applicant must not commence construction of the access road or quarrying operations until the Biodiversity Management Plan is approved by the Planning Secretary.

B48.B49. The Applicant must implement the approved Biodiversity Management Plan.

#### **Rehabilitation Objectives**

B49.B50. The Applicant must rehabilitate the site to the satisfaction of the Planning Secretary. This rehabilitation must be consistent with the rehabilitation strategy set out in the EIS and the conceptual rehabilitation plan in Appendix 6 and must comply with the objectives in Table 6Table 6.

**Note:** The rehabilitation objectives related to the establishment of native vegetation communities do not constitute an obligation or biodiversity offset purposes. Biodiversity offsets obligations in relation to development approved under this consent are regulated by conditions <u>B43</u>B41-to-<u>B46</u>B44.

#### **Progressive Rehabilitation**

- B50.<u>B51.</u> The Applicant must rehabilitate the site progressively, that is, as soon as reasonably practicable following disturbance. All reasonable steps must be taken to minimise the total area exposed at any time. Interim stabilisation and temporary vegetation strategies must be employed when areas prone to dust generation, soil erosion and weed incursion cannot be permanently rehabilitated.
  - **Note:** It is accepted that some parts of the site that are progressively rehabilitated may be subject to further disturbance at some later stage of the development.

#### Rehabilitation Management Plan

- B51.B52. Within 12 months of commencement of development under this consent, the Applicant must prepare a Rehabilitation Management Plan for the development to the satisfaction of the Planning Secretary. This plan must:
  - (a) be prepared by suitably qualified and experienced person/s;
  - (a)(b) be prepared in consultation with Council;
  - (c) describe the short, medium, and long-term measures to be undertaken to ensure compliance with the rehabilitation objectives in this consent;
  - (b)(d) describe the staging and timing of the progressive rehabilitation required by condition B51;
  - (c)(e)\_include a conceptual closure plan that considers the hydrological and hydraulic impacts of the final landform;
  - (d)(f) include detailed performance and completion criteria for evaluating the performance of rehabilitation of the site, including triggers for remedial action, where these performance or completion criteria are not met;
  - (e)(g) include a seasonally-based program to monitor and report on the effectiveness of rehabilitation measures, progress against the detailed performance and completion criteria, and any progressive improvements that could be implemented to improve rehabilitation outcomes;
  - (f)(h) monitor and report on the impacts of the development on groundwater dependent ecosystems and riparian vegetation, and identify trigger levels for the remediation of any material impacts to these ecosystems;
  - (g)(i) identify the potential risks to the successful implementation of the final rehabilitation, and include a description of the contingency measures to be implemented to mitigate against these risks; and
  - (h)(i) include details of who would be responsible for monitoring, reviewing, and implementing the plan.

B52.B53. The Applicant must implement the approved Rehabilitation Management Plan.

#### Rehabilitation Bond

- B53.B54. Within 6 months of the approval of the Rehabilitation Management Plan, the Applicant must lodge a Rehabilitation Bond with the Department to ensure that the rehabilitation of the site is undertaken in accordance with the performance and completion criteria set out in the plan and the relevant conditions of this consent. The sum of the bond must be an amount agreed to by the Planning Secretary and determined by:
  - (a) calculating the cost of rehabilitating all existing and immediately proposed disturbed areas of the site (taking into account likely surface disturbance over the next 3 years of quarrying operations); and
  - (b) employing a suitably qualified, independent and experienced person to verify the calculated costs.
- B54.B55. The calculation of the Rehabilitation Bond must be submitted to the Department for approval at least 1 month prior to the proposed lodgement of the bond.
- B55.B56. The Rehabilitation Bond must be reviewed and if required, an updated bond must be lodged with the Department within 3 months following:
  - (a) any update or revision to the Rehabilitation Management Plan;
  - (b) completion of an Independent Environmental Audit in which recommendations relating to rehabilitation have been made; or
  - (c) a request by the Planning Secretary,
- B56.B57. If rehabilitation of this site is completed generally in accordance with the relevant performance and completion criteria, to the satisfaction of the Planning Secretary, the Planning Secretary will release the bond.
- B57.B58. If rehabilitation of the site is not completed generally in accordance with the relevant performance and completion criteria, the Planning Secretary will call in all, or part of, the bond, and arrange for the completion of the relevant works.

## VISUAL

B58.B59. The Applicant must:

- (a) take all reasonable steps to minimise the visual and off-site lighting impacts of the development;
- (b) ensure that all external lighting associated with the development complies with relevant Australian Standards including *Australian Standard AS4282 (INT) 1997 Control of Obtrusive Effects of Outdoor Lighting*;

- (c) ensure that the visual appearance of all buildings, structures, facilities or works (including paint colours and specifications) is aimed at blending as far as possible with the surrounding landscape; and
- (d) take all reasonable steps to shield views of quarrying operations and associated equipment from users of public roads and privately-owned residences.

## WASTE

B59.B60. The Applicant must:

- (a) manage on-site sewage treatment and disposal in accordance with the requirements of an applicable EPL, and to the satisfaction of EPA;
- (b) classify all waste in accordance with the Waste Classification Guidelines (EPA, 2014);
- (c) minimise the waste generated by the development;
- (d) ensure that the waste generated by the development is appropriately stored, handled, and disposed of; and
- (e) monitor and report on waste minimisation and management in the Annual Review referred to in condition D9.
- B60.B61. Except as expressly permitted in an applicable EPL, specific resource recovery order or exemption under the Protection of the Environment Operations (Waste) Regulation 2014, the Applicant must not receive waste at the site for storage, treatment, processing, reprocessing or disposal.

## LIQUID STORAGE

B61.B62. The Applicant must ensure that all tanks and similar storage facilities (other than for water) are protected by appropriate bunding or other containment, in accordance with the relevant Australian Standards.

## DANGEROUS GOODS

B62.B63. The Applicant must ensure that the storage, handling, and transport of dangerous goods is done in accordance with the latest version of the Australian Standards, particularly AS 1940-2004 The storage and handling of flammable and combustible liquids (Standards Australia, 2004) and AS/NZS 1596:2014 The storage and handling of LP Gas (Standards Australia, 2014), and the Australian Dangerous Goods Code.

## **BUSHFIRE MANAGEMENT**

B63.B64. The Applicant must:

- (a) ensure that the development:
  - (i) provides for asset protection in accordance with the relevant requirements in *the Planning for Bushfire Protection* (RFS, 2019) guideline; and
  - (ii) ensure that there is suitable equipment to respond to any fires on the site; and
- (b) assist the RFS and emergency services to the extent practicable if there is a fire in the vicinity of the site.

## PART C ADDITIONAL PROCEDURES

## NOTIFICATION OF EXCEEDANCES

- C1. As soon as practicable and no longer than 7 days after obtaining monitoring results showing an exceedance of any noise, blasting or air quality criterion in PART B of this consent, the Applicant must:
  - (a) provide to any affected landowners and tenants; and
  - (b) publish on its website

the full details of the exceedance.

C2. For any exceedance of any air quality criterion in PART B of this consent, the Applicant must also provide to any affected landowners and tenants a copy of the fact sheet entitled "*Mine Dust and You*" (NSW Minerals Council, 2011).

## INDEPENDENT REVIEW

- C3. If a landowner considers the development to be exceeding any noise, blasting or air quality criterion in PART B of this consent, they may ask the Planning Secretary in writing for an independent review of the impacts of the development on their land.
- C4. If the Planning Secretary is not satisfied that an independent review is warranted, the Planning Secretary will notify the landowner in writing of that decision, and the reasons for that decision, within 21 days of the request for a review.
- C5. If the Planning Secretary is satisfied that an independent review is warranted, within 3 months of the Planning Secretary's decision, or as otherwise agreed by the Planning Secretary and the landowner, the Applicant must:
  - (a) commission a suitably qualified, experienced and independent person, whose appointment has been approved by the Planning Secretary, to:
    - (i) consult with the landowner to determine their concerns;
    - (ii) conduct monitoring to determine whether the development is complying with the relevant criteria in PART B of this consent; and
    - (iii) if the development is not complying with any relevant criterion, identify measures that could be implemented to ensure compliance with that criterion;
  - (b) give the Planning Secretary and landowner a copy of the independent review; and
  - (c) comply with any written requests made by the Planning Secretary to implement any findings of the review.

## PART D ENVIRONMENTAL MANAGEMENT, REPORTING AND AUDITING

## ENVIRONMENTAL MANAGEMENT

## Environmental Management Strategy

- D1. An Environmental Management Strategy must be prepared for the development. This strategy must:
  - (a) provide the strategic framework for environmental management of the development;
  - (b) identify the statutory approvals that apply to the development;
  - (c) set out the role, responsibility, authority and accountability of all key personnel involved in the environmental management of the development;
  - (d) set out the procedures to be implemented to:
    - (i) keep the local community and relevant agencies informed about the operation and environmental performance of the development;
    - (ii) receive record, handle and respond to complaints;
    - (iii) resolve any disputes that may arise during the course of the development;
    - (iv) respond to any non-compliance and any incident;
    - (v) respond to emergencies; and
  - (e) include:
    - (i) references to any strategies, plans and programs approved under the conditions of this consent; and
    - (ii) a clear plan depicting all the monitoring to be carried out under the conditions of this consent.
- D2. The Applicant must not commence construction or quarrying operations until the Environmental Management Strategy is approved by the Planning Secretary.
- D3. The Applicant must implement the approved Environmental Management Strategy.

#### **Management Plan Requirements**

- D4. Management plans required under this consent must be prepared in accordance with relevant guidelines, and include:
  - (a) a summary of relevant background or baseline data;
  - (b) details of:
    - (i) the relevant statutory requirements (including any relevant approval, licence or lease conditions);
    - (ii) any relevant limits or performance measures and criteria; and
    - (iii) the specific performance indicators that are proposed to be used to judge the performance of, or guide the implementation of, the development or any management measures;
  - (c) a description of the measures to be implemented to comply with the relevant statutory requirements, limits, or performance measures and criteria;
  - (d) a program to monitor and report on the:
    - (i) impacts and environmental performance of the development; and
    - (ii) effectiveness of the management measures set out pursuant to condition D4(c);
  - (e) a contingency plan to manage any unpredicted impacts and their consequences and to ensure that ongoing impacts reduce to levels below relevant impact assessment criteria as quickly as possible;
  - (f) a program to investigate and implement ways to improve the environmental performance of the development over time;
  - (g) a protocol for managing and reporting any:
    - (i) incident, non-compliance or exceedance of the impact assessment criteria or performance criteria;
    - (ii) complaint; or
    - (iii) failure to comply with statutory requirements; and
  - (h) a protocol for periodic review of the plan.
  - **Note:** The Planning Secretary may waive some of these requirements if they are unnecessary or unwarranted for particular management plans.

## **REVISION OF STRATEGIES, PLANS AND PROGRAMS**

- D5. Within three months of:
  - (a) the submission of an incident report under condition D7;
  - (b) the submission of an Annual Review under condition D9;

- (c) the submission of an Independent Environmental Audit under condition D11;
- (d) the approval of any modification of the conditions of this consent;
- (e) notification of a change in development stage under condition A19; or
- (f) the issue of a direction of the Planning Secretary under condition A2(b) which requires a review,

the suitability of existing strategies, plans and programs required under this consent must be reviewed by the Applicant.

- D6. If necessary, to either improve the environmental performance of the development, cater for a modification or comply with a direction, the strategies, plans and programs required under this consent must be revised, to the satisfaction of the Planning Secretary and submitted to the Planning Secretary for approval within six weeks of the review.
  - **Note:** This is to ensure strategies, plans and programs are updated on a regular basis and to incorporate any recommended measures to improve the environmental performance of the development.

## **REPORTING AND AUDITING**

## **Incident Notification**

D7. The Planning Secretary must be notified in writing via the Major Projects Portal immediately after the Applicant becomes aware of an incident. The notification must identify the development (including the application number and the name of the development if it has one) and set out the location and nature of the incident. Subsequent notification requirements must be given, and reports submitted in accordance with the requirements set out in Appendix 7.

## **Non-Compliance Notification**

D8. The Planning Secretary must be notified in writing via the Major Projects Portal within seven days after the Applicant becomes aware of any non-compliance. A non-compliance notification must identify the development and the application number for it, set out the condition of the consent that the development is non-compliant with, the way in which it does not comply and the reasons for the non-compliance (if known) and what actions have been, or will be, undertaken to address the non-compliance.

**Note**: A non-compliance which has been notified as an incident does not need to also be notified as a non-compliance.

## Annual Review

- D9. By the end of March in each year after the commencement of development, or other timeframe agreed by the Planning Secretary, a report must be submitted to the Department reviewing the environmental performance of the development, to the satisfaction of the Planning Secretary. This review must:
  - (a) describe the development (including any rehabilitation) that was carried out in the previous calendar year, and the development that is proposed to be carried out over the current calendar year;
  - (b) include a comprehensive review of the monitoring results and complaints records of the development over the previous calendar year, including a comparison of these results against the:
    - (i) relevant statutory requirements, limits or performance measures/criteria;
    - (ii) requirements of any plan or program required under this consent;
    - (iii) monitoring results of previous years; and
    - (iv) relevant predictions in the documents listed condition A2(c).
  - (c) identify any non-compliance or incident which occurred in the previous calendar year, and describe what actions were (or are being) taken to rectify the non-compliance and avoid reoccurrence;
  - (d) evaluate and report on:
    - (i) the effectiveness of the noise and air quality management systems; and
    - (ii) compliance with the performance measures, criteria and operating conditions in this consent;
  - (e) identify any trends in the monitoring data over the life of the development;
  - (f) identify any discrepancies between the predicted and actual impacts of the development, and analyse the potential cause of any significant discrepancies; and
  - (g) describe what measures will be implemented over the current calendar year to improve the environmental performance of the development.
- D10. Copies of the Annual Review must be submitted to Council and made available to the CCC and any interested person upon request.

## Independent Environmental Audit

D11. Within one year of the commencement any development under this consent, and every three years after, unless the Planning Secretary directs otherwise, the Applicant must commission and pay the full cost of an Independent Environmental Audit of the development. The audit must:

- (a) be led and conducted by a suitably qualified, experienced and independent team of experts whose appointment has been endorsed by the Planning Secretary;
- (b) be carried out in consultation with the relevant agencies and the CCC;
- (c) assess the environmental performance of the development and whether it is complying with the relevant requirements in this consent, water licences and EPL for the development (including any assessment, strategy, plan or program required under these approvals);
- (d) review the adequacy of any approved strategy, plan or program required under this consent and the other abovementioned approvals;
- (e) recommend appropriate measures or actions to improve the environmental performance of the development and any assessment, strategy, plan or program required under this consent and the other abovementioned approvals; and
- (f) be conducted and reported to the satisfaction of the Planning Secretary.
- D12. Within three months of commencing an Independent Environmental Audit, or within another timeframe agreed by the Planning Secretary, the Applicant must submit a copy of the audit report to the Planning Secretary, and any other NSW agency that requests it, together with its response to any recommendations contained in the audit report, and a timetable for the implementation of the recommendations. The recommendations must be implemented to the satisfaction of the Planning Secretary.
  - **Note:** The audit team must be led by a suitably qualified auditor and include experts in any fields specified by the Planning Secretary.

## Monitoring and Environmental Audits

D13. Any condition of this consent that requires the carrying out of monitoring or an environmental audit, whether directly or by way of a plan, strategy or program, is taken to be a condition requiring monitoring or an environmental audit under Division 9.4 of Part 9 of the EP&A Act. This includes conditions in respect of incident notification, reporting and response, non-compliance notification, compliance report and independent audit.

For the purposes of this condition, as set out in the EP&A Act, "monitoring" is monitoring of the development to provide data on compliance with the consent or on the environmental impact of the development, and an "environmental audit" is a periodic or particular documented evaluation of the development to provide information on compliance with the consent or the environmental management or impact of the development.

D14. Noise, blast and/or air quality monitoring under this consent may be undertaken at suitable representative monitoring locations instead of at privately-owned residences or other locations listed in PART B of this consent, providing that these representative monitoring locations are set out in the respective management plan/s.

#### ACCESS TO INFORMATION


- D15. Before the commencement of construction until the completion of all rehabilitation required under this consent, the Applicant must:
  - (a) make the following information and documents (as they are obtained, approved or as otherwise stipulated within the conditions of this consent) publicly available on its website:
    - (i) the document/s listed in condition A2(c);
    - (ii) all current statutory approvals for the development;
    - (iii) all approved strategies, plans and programs required under the conditions of this consent;
    - (iv) minutes of CCC meetings;
    - (v) regular reporting on the environmental performance of the development in accordance with the reporting requirements in any plans or programs approved under the conditions of this consent;
    - (vi) a comprehensive summary of the monitoring results of the development, reported in accordance with the specifications in any conditions of this consent, or any approved plans and programs;
    - (vii) a summary of the current stage and progress of the development;
    - (viii) contact details to enquire about the development or to make a complaint;
    - (ix) a complaints register, updated monthly;
    - (x) the Annual Reviews of the development;
    - (xi) audit reports prepared as part of any Independent Environmental Audit of the development and the Applicant's response to the recommendations in any audit report;
    - (xii) any other matter required by the Planning Secretary; and
  - (b) keep such information up to date, to the satisfaction of the Planning Secretary.


## APPENDIX 1: SCHEDULE OF LAND

## APPENDIX 4: NOISE COMPLIANCE ASSESSMENT

## **Applicable Meteorological Conditions**

- 1. The noise criteria in <u>Table 2</u> of the conditions are to apply under all meteorological conditions except the following:
  - (a) where 3°C/100 metres (m) lapse rates have been assessed, then:
    - (i) wind speeds greater than 3 metres/second (m/s) measured at 10m above ground level;
    - (ii) temperature inversion conditions between 1.5°C and 3°C/100m and wind speeds greater than 2m/s measured at 10m above ground level; or
    - (iii) temperature inversion conditions greater than 3°C/100m.
  - (b) where Pasquill Stability Classes have been assessed, then:
    - (i) wind speeds greater than 3m/s at 10m above ground level;
    - (ii) stability category E or F and wind speeds greater than 2m/s at 10m above ground level; or
    - (iii) stability category G temperature inversion conditions.


#### **Determination of Meteorological Conditions**

2. Except for wind speed at microphone height, the data to be used for determining meteorological conditions shall be that recorded by the meteorological station required under B21.

## **Compliance Monitoring**

- 3. A noise compliance assessment must be undertaken within two months of commencement of the road transportation of quarry products. The assessment must be conducted by a suitably qualified and experienced acoustical practitioner and must assess compliance with noise criteria presented above. A report must be provided to the Department and EPA within 1 month of the assessment.
- 4. Unless otherwise agreed by the Planning Secretary, attended compliance monitoring must be carried out in accordance with the relevant requirements for reviewing performance set out in the NSW Noise Policy for Industry (EPA, 2017), in particular the requirements relating to:
  - (a) monitoring locations for the collection of representative noise data;
  - (b) meteorological conditions during which collection of noise data is not appropriate;
  - (c) equipment used to collect noise data, and conformity with Australian Standards relevant to such equipment; and
  - (d) modifications to noise data collected, including for the exclusion of extraneous noise and/or penalties for modifying factors apart from adjustments for duration,
  - (e) modifying factors apart from adjustments for duration,

with the exception of applying appropriate modifying factors for low frequency noise during compliance testing. This should be undertaken in accordance with *Fact Sheet C* of the *NSW Noise Policy for Industry (EPA, 2017)*.

## APPENDIX 7: INCIDENT NOTIFICATION AND REPORTING REQUIREMENTS

#### Written Incident Notification Requirements

- 1. A written incident notification addressing the requirements set out below must be submitted to the Planning Secretary via the Major Projects website within seven days after the Applicant becomes aware of an incident. Notification is required to be given under this condition even if the Applicant fails to give the notification required under condition D7 of this consent or, having given such notification, subsequently forms the view that an incident has not occurred.
- 2. Written notification of an incident must:
  - a) identify the development and application number;
  - b) provide details of the incident (date, time, location, a brief description of what occurred and why it is classified as an incident);
  - c) identify how the incident was detected;
  - d) identify when the applicant became aware of the incident;
  - e) identify any actual or potential non-compliance with conditions of consent;
  - f) describe what immediate steps were taken in relation to the incident;
  - g) identify further action(s) that will be taken in relation to the incident; and
  - h) identify a project contact for further communication regarding the incident.
- 3. Within 30 days of the date on which the incident occurred or as otherwise agreed to by the Planning Secretary, the Applicant must provide the Planning Secretary and any relevant public authorities (as determined by the Planning Secretary) with a detailed report on the incident addressing all requirements below, and such further reports as may be requested.
- 4. The Incident Report must include:
  - a) a summary of the incident;
  - b) outcomes of an incident investigation, including identification of the cause of the incident;
  - c) details of the corrective and preventative actions that have been, or will be, implemented to address the incident and prevent recurrence; and
  - d) details of any communication with other stakeholders regarding the incident.
