I have some concerns to raise regarding the public meeting in Dunedoo as follows , I firstly question the choice by the commmission for the meeting to be held at Dunnedoo, With only around 9 % of the proposed wind farm in Warrumbungle shire and 91% of the Wind farm being in Dubbo Shire ,I would have thought it more relevant for the meeting to be heard at a location,perhaps where the impacts of the wind farm will be most likely felt , Gollan Hall for instance, this would have allowed for a good turn out actual potential affected parties to attend . There seems to have been extended discussions with Warrumbungle Shire , but no mention of and discussion with Dubbo Shire Council or its possible affected or beneficially impacted communities it seems a little lacking. Just regarding over the speakers, I wonder and take caution as to many of their relevance to this Spicer's Creek application, There seemed to be a lot of misrepresentation, in particular of parties ,groups and individuals from outside the Spicer's Creek application area ,We heard from speakers from Goulburn and Yass, Uarby and Coolah, and who knows were else, all trying to push in my view a lopsided agenda, None of whom are known or relevant to the proposed Spicers Creek Wind Farm or it's affected or beneficially impacted communities, seemed to be a minority looking for a Negative instead of the Positive, they certainly don't speak for me or on my family's behalf.I felt they conveyed their false ideals with bitterness and resentment and it took away from the select few locals present their with genuine reasons for concern and objection.
