Topic 1. Sustainability of current and future forestry operations in NSW

NSW forestry corporation is not operating in a "best practice" model. Recently released "Breaches" by Miriam Pepper and Jason Johns profiles breaches by FCNSW since the Black Summer bushfires. Recently FCNSW has been fined over \$300, 000 on a breach of environmental regulations. As an Australian tax payer I resent my taxes being used to destroy precious habitat. If forests operations are to be viable they need to be "best practices" and not run at a loss. It needs to take into account scientific evidence and not be a cow boy approach to slash, burn and poison.

At the moment the only viable wild koala population will be on the east coast , in the native forests and also some plantations. Also for Greater Gliders and yet prime habitat for these 2 endangered species is at this very moment being destroyed.eg . Tuckers Nob Shea's Nob , Bulga state forests and on line Little Newry and Pine Creek state forest and Viewmont . This is ludicrous. Sadly Newry state forest was logged last year and a sacred fire that the local Gumbaynnggir people had created was disrespectfully destroyed by Urunga fire brigade while the Indigenous elders and others looked on in tears and begging for respect . What hope have we as a community if we continue to bring colonial practices to how we treat the indigenous peoples of Australia. The effort to allow the indigenous people back onto Newry to find significant cultural objects (as was directed by the Land and Environment Court) was a total sham as they were not allowed to leave the firetrails and shepherded by forestry workers.
