#### Topic 1. Sustainability of current and future forestry operations in NSW

Native forest logging should be halted as soon as possible by phasing out all operations in these areas over the immediate future (5years). It is unsustainable impacting directly on landscapes, soils, soil biota, water and catchment hydrology, and all living things.
