Topic 1. Sustainability of current and future forestry operations in NSW

Current forestry practices are not harvesting native state forests at sustainable levels. We are sacrificing priceless habitat and environmental assets for short term financial benefits. And often for relatively worthless wood chipped products. To go into these forests, such as the Styx River forests is to see destruction rather than sustainability. We need sustainable plantation timber not logging our native forests.

Topic 2. Environmental and cultural values of forests, including threatened species and Aboriginal cultural heritage values

Australian's native forests contain vital habitat for our threatened animals including greater gliders, barking owls and many more species. The logging practices do not leave enough den trees or feed trees to support the animals and birds that live there. These den trees take 150 yrs of growth.
