### **MOSS VALE PLASTIC RECYCLING FACILITY (SSD-9409987)**

Thank you for the opportunity to again state my objections to this project.

I have lived in this Shire since 1962. I have been a community representative on the Sydney Catchment Management Committee and Wingecarribee Environment Committee and represented Landcare. I have worked for 35 years as a Bush Regenerator in the Shire and contributed to the production of the long term Strategy.

1. **Water.** The proposed site is in part of the Upper Sydney Drinking Water Catchment. I understand concerns about pollution of the Drinking Water Catchment. This project does not present a 'neutral or beneficial effect' let alone define the proposed consumption of our finite water supply.
2. **Conservation.** For the last 35 years members of our community have spent time and much labour trying to conserve the native habitat and the waterways with hours and hours of bush regeneration and replanting. It was understood that the Dept of Planning, Environment and Water was supporting this work. It is very important that it continues to support this concept of maintaining our Clean, Green and Quiet Shire.
3. **Ambience.** This Shire is part of the lungs and kidneys for the people of Greater Sydney, it supplies beautiful water, clean air, peace and quiet for spiritual replenishment and considerable habitat for our biodiversity. Under no circumstances should this be put at risk.
4. **This refinery will corrupt** the water potential, pollute the air, disrupt a peaceful residential area and upset the environment with noise, light and traffic.
5. **Concerns.** I understand similar projects in Europe have been found to fail their major purpose by creating more pollution than the plastic itself.
  - b. This company has no experience in the business
  - c. Approval of this project will not provide 'intergenerational equity' nor the "precautionary principle"
  - d. It is illegal to remove *Eucalyptus macarthurii* from the proposed site
  - e. the noise, dust, danger of increased truck traffic, potential water and air pollution does not conform with the Shire's 'Clean, Green and Quiet' objective

I am OPPOSED to approval of this project.
