I would like to express my deep concern and total opposition for the abovementioned State Significant Development by Plasrefine Recycling Pty Ltd. It is a disaster for the Southern Highlands for so many reasons, some stated below.

I have lived in Bowral for 25 years and have seen the steady population growth of the Southern Highlands over that time, with a spike in growth and new sub-divisions over the last few years, and continuing with more huge housing developments proposed in the southern towns (ie Moss Vale, Canyonleigh) expected in coming years.

The area in general cannot support the influx of heavy trucks (up to 50 per day) thundering through the small towns and clogging access from the highway to local businesses and homes. Our towns are already compromised with heavy traffic from the thousands of new families who have chosen a quieter, rural life and who have invested in recently built homes and relocated to the highlands for the lifestyle, excellent local schools and "village feel" on offer.

Hazardous pollution emitted from smoke, microplastic sludge waste and airborn, noise, dust and toxic fumes are a real health hazard to residents near and far. Should a fire occur at the facility, which has been evident at many other plastics recycling facilities, (recently nearby Picton), there is no capability of local ~on call' fire services to deal with a HAZMAT disaster of such a monumental scale. This would also cause evacuation of thousands of residents.

The bulk and scale of this huge structure is a blight on the beautiful landscape of the Southern Highlands, with 22+ metre exhaust stacks, 15+ metre building height, a footprint of 8 football fields, brightly lit up and operating 24/7, and visible for miles.

Being adjacent to residential properties and a childcare facility is clearly the wrong location for such an enormous structure, with the final design and details yet to be accurately documented and finalised ~after approval'! It will not be in any way architecturally sympathetic and will be concerningly detrimental to residential property values near and far in adjoining towns.

The impact on wildlife, water quality containing microplastics (and supplying Sydney's water), endangered trees and vegetation are also of critical concern as it is not an approved heavy industry site, and does not support council's ~clean and green' vision for that location.
