Thanks for your team's time earlier today. The Panel has proposed some minor changes to the recommended conditions of consent. We're seeking the Department's comment on the feasibility, workability, and any potential unintended consequences of these changes set out below.

- C36: typo – change “validated” to “[validate](#)”

- C38: consistency with C37 and to capture potential unexpected outcomes – change “the remediation works” to “**any** remediation works”
- C39: consistency with C37 & C38 and to capture potential unexpected outcomes – change “the remediation works” to “**any** remediation works”
- C40: consistency with C37, C38, C39 and to capture potential unexpected outcomes – change “the remediation works” to “**any** remediation works”
